### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to execute sole source Contract 23M005A with Wabtec Railway Electronics to establish a maintenance support agreement for the NorthStar Commuter Rail Positive Train Control system in an amount not to exceed \$990,000.

### Background

As the equipment owner, NorthStar is required to maintain Positive Train Control (PTC) equipment on the rolling stock. Wabtec Railway Electronics PTC systems that are onboard NorthStar are proprietary software and will provide additional support services required to maintain and operate the Federal Railroad Administration required PTC systems on NorthStar's equipment. To maintain the PTC systems software that runs on NorthStar equipment the maintenance support agreement is a requirement by Wabtec. Without this agreement the Council is not authorized by Wabtec to run their software on our equipment.

This Work Order Contract is associated with the Wabtec Master Agreement 23M005 which provides engineering, design, programming, testing, and integration services related to the Metro Transit light rail signal, communications, SCADA, and PACIS systems and the Northstar signal, communications, SCADA, PACIS, and PTC systems.

### Rationale

The execution of a professional services contract exceeding \$500,000 requires Council approval.

### **Thrive Lens Analysis**

### **Funding**

The funding is available within NorthStar's operating budget, council approved operating budget.
