#### **Proposed Action**

That the Metropolitan Council designate the attached list of Council properties as potential TOD sites eligible for use of the TOD fund allocated to the TOD Office. Funds will be used for expenses necessary to advance TOD opportunities on these sites. Examples of expenses include due diligence work such as title reports, surveys, appraisals, market studies, engineering studies, etc.

## Background

It has been determined that the TOD fund may only be used to advance TOD opportunities on sites approved by Council. This action will update the potential TOD sites list approved by Council on December 27, 2017 (Business item 2017-267). The TOD Office has reviewed the approved list of sites and other Council-owned sites by consulting various Council staff and by analyzing site size, proximity to transit service, surrounding areas, and existing uses. The attached revised list of sites reflects that work. Two sites will be removed from the potential TOD site list due to a planned or completed disposition of the Council-owned property. Nine sites will be added.

This item will allow Council staff to evaluate feasibility and advance competitive solicitations for TOD sites. Any non-competitive proposed TOD project and any final decision concerning any specific TOD project will require separate Council action.

## Rationale

This item updates the list of potential TOD sites eligible for use of the TOD fund.

## **Thrive Lens Analysis**

Designation of potential TOD sites facilitates future TOD on Council-owned property. This advances several Thrive outcomes:

Stewardship: TOD is anticipated to generate new transit ridership and revenue for Metro Transit.

Prosperity: TOD facilitates private investment on sites that are located adjacent to significant existing and future transit service.

Equity: TOD is anticipated to increase access to opportunity, including jobs, housing, goods, and services along transit.

Livability: TOD elevates active transportation, including transit, as a feasible travel option. It also increases the volume and variety of activity that occurs around Metro Transit's transit stations which can improve perceptions of safety.

Sustainability: TOD, and compact development in general, can help reduce habitat fragmentation, reduce habitat loss, and reduce the need to use single-occupant vehicles. Locating new development near frequent transit is also an important tool for reducing regional climate-warming emissions.

#### Funding

As of February 16, 2024 there is \$940,989 unencumbered in the TOD Fund. This fund was funded with property taxes.

#### **Small Business Inclusion**

There are no direct impacts to small business with this action. Any future competitive solicitations associated with this action will be evaluated by the Office of Equity and Equal Opportunity (OEEO) to determine if there are opportunities for small business and potential small business subcontracting goals.
