






Grand Round North Regional Trail

Community and Partner Engagement

Who was engaged?

- Residents all along the trail route:
 - McDonough Homes
 - Commonwealth Terrace Cooperative
 - Dayton's Bluff, Payne-Phalen, North End, Como, St. Anthony Park, Union Park neighborhoods
- Agencies including the Minnesota Department of Transportation, Ramsey County, and Metro Transit
- Advocacy non-profits including the Saint Paul Bicycle Coalition and Move Minnesota.

How was the community engaged?

- Pop-up events along the Grand Round route
- Listening sessions with community organizations
- Engagement events held in coordination with larger community events
- Presentations at District Council meetings
- A four-day design workshop
- Online engagement including an online survey
- Open house meetings
- Community Advisory Committee meetings made up of citizen representatives

Community Engagement

What did participants say?

- Support for the plan was prevalent.
- Users include both pedestrians and bicyclists. The needs of each user group must be considered.
- Participants expressed a preference for facilities separated from motor vehicles.
- Safety was a concern for many participants.
- Amenities such as restrooms, water fountains and benches are desired.
- Connections and better wayfinding to existing trails are desired.







Overall Development Concept

- All segments and facilities will be constructed to be compliant with the Americans with Disabilities Act.
- Standard design is a 10 ft bike trail when parallel to a minimum 5 ft sidewalk or 12 ft wide where there is not sufficient space for an adjacent pedestrian facility.
- Approximately one-third of the trail has been constructed since adoption of the 2017 Grand Round Design and Implementation Plan.
- The trail will not be considered fully realized until all trails are off-street.



Estimated Project Costs

- No acquisitions are necessary to develop the trail
- Development cost estimates include:
 - trail construction
 - wayfinding signage
 - site furnishings (e.g., benches, drinking fountains, bicycle racks, bicycle repair stations, waste/ recycling receptacles)
 - lighting
 - vegetation improvements
- Approval of master plan does not commit the Council to any funding at this time.

Rationale for Proposed Action

- The Grand Round North Regional Trail Master Plan is consistent with the requirements of the:
 - 2040 Regional Parks PolicyPlan
 - Planning Policy Strategy 1
 - Other Council policies





Proposed Action

That the Metropolitan Council:

- 1. Approve the City of Saint Paul's Grand Round North Regional Trail Master Plan.
- 2. Require the City of Saint Paul, prior to initiating any new development of the regional trail corridor, to send preliminary plans to the Metropolitan Council's Environmental Services Division Assistant Manager.
- 3. Encourage the City of Saint Paul to implement advisory comments in the "Consistency with Other Council Policies and Systems" section regarding stormwater, natural resources and solar.
