## **Home Interview Data: Seven-County Metropolitan Area**

## 1. Household Characteristics

- The median household size in the seven-county metro area is two people; the average is 2.46 people. (Table 9)
- Scott County has the largest average household size, with 2.81 persons per household. (Tables 10 through 20)
- Hennepin and Ramsey Counties have the lowest average household size with 2.33 and 2.35, respectively. (Tables 10 through 20)
- The average annual household income is \$57,700. (Table 22)
- More than half (57%) of household members are employed; 5% have more than one job; and 22% said they were students and not employed. (Table 23)
- Most workers (80%) worked 40 or more hours per week. (Table 24)
- Mean hours worked by employed persons was 45 hours per week. (Table 23)
- The average number of vehicles available to the household was 1.80. (Table 25)
- Just under 5% of the households do not have a vehicle available for their use. (Table 25)
- Just over 2% of the households do not have a licensed driver. (Table 27)
- The average number of licensed drivers per household is 1.75. When compared to 1.80 vehicles available per household, the result is that there are 1.03 vehicles per driver. (Table 28)
