METROPOLITAN SIGNIFICANCE OVERVIEW

Legal Basis: Minnesota Statutes 473.173 and Minnesota Rules Chapter 5800.

<u>Purpose:</u> To assure full consideration of a project; to assure orderly and economical development; to arrive at consensus on the issues.

<u>Meaning:</u> A proposed project in one city may have substantial negative impact on another city, or substantial financial impact on a publicly funded facility, or impact on a regional system.

<u>Power:</u> To review matters and to suspend action on a proposed matter during a period of review for up to 12 months.

<u>Proposed Project:</u> Project or action "involving construction, installation, establishment, siting, demolition, reconstruction, or improvement of any structure or facility, or the subdivision or drilling, extraction, clearing, excavation, or other alteration of any lands or waters, planned or proposed to be undertaken, in whole or in part within the metropolitan area, by any person."

<u>Initiation of Review:</u> By "requesters" or the Council. Also, resolution from a unit of government in which the project is located; resolution from affected governmental unit; petition signed by 5,000 adult residents of metropolitan area; at least 50% of persons who voted in the affected government's last general election; resolution or letter from board or executive officer of a state agency; resolution or letter from board or executive officer of sponsor of the project; resolution from affected metropolitan agency.

<u>Commencement of Review:</u> Chair examines information submission and makes preliminary finding of metropolitan significance, issues order for commencement.

Notice of Commencement: Council serves notice of commencement of review on all parties, adjacent governmental units, metropolitan agencies, and LUAC within 5 days of determination.

Review Period: Council must complete the review within 90 days following commencement unless the review is suspended or extended in accordance with laws and rules.

<u>Criteria to Find Metropolitan Significance:</u> Three ways: project affects metropolitan system; publicly subsidized project threatens publicly-financed project; project has substantial physical effect on a local government other than the unit in which the project is located.

<u>Review Alternatives:</u> Chair may decide project under review is more suited to mediation, suspend review for 30 days. If mediation does not resolve differences, a public hearing must be held either before review committee or an administrative law judge.

<u>Hearing:</u> Within 30 days after review is commenced, parties submit to the review committee or ALJ a preliminary statement on the effect and significance of the project and appropriate remedy. Council staff prepares written report. Burden of proof that a matter is of metropolitan significance is on the Council.

<u>Committee Report:</u> Following public hearing, review committee must adopt a committee report with findings of fact, conclusions and recommendations to the MetropolitanCouncil.

<u>Final Determination</u>: The Council must adopt a final determination including findings of fact, conclusions, and recommendations with regard to the metropolitan significance of the project, including a finding that the project is or is not of metropolitan significance. Final determination must indicate: whether the Council intends to initiate a system plan amendment to achieve consistency with the project; whether the project should be suspended for up to one year and whether there are conditions which, if complied with, would cause the Council to eliminate the suspension; or, without ordering a suspension, how the project could be modified to eliminate the determination of metropolitan significance.
