The Trivie outcomes – stewardship, prosperity, equity, livability and sustainability – are folty ideals that cut across the Council's functions and responsibilities. Collaboration



Collaboration • •

Collaboration recognizes that shared efforts advance our region most effectively toward shared outcomes. Addressing the region's issues—particularly the emerging challenges of climate change, economic competitiveness, racial disparities, and water sustainability—requires collaboration because no single entity has the capacity or the authority to do the work alone.

Even when one entity is the primary funder or investor in a project, success requires the coordinated collaboration of a range of public and private entities to fully realize the development potential—witness, for example, the extensive partnerships supporting development beyond the rails along the METRO Green Line (Central Corridor).

For the Council, acting collaboratively means:

- Being open to shared strategies, supportive partnerships, and reciprocal relationships.
- Convening the region's best thinkers, experts, and stakeholders to address complex regional issues beyond the capacity or authority of any single jurisdiction or institution.
- Providing additional technical assistance and enhanced information to support local planning and decision-making.

Task Force Findings

Consensus Items:

- Reasons for wastewater reuse program
- Responsive approach
- Cooperation and partnership rather than competition
- Cost-of-service basis for reclaimed water rate
- Regional benefit evaluation
- Funding from non-Council funds
- <u>If</u> Council moves ahead with regional cost share, implement a pilot wastewater reuse program with: caps on cost share, user agreement, public input process, Council decision making

Conclusions from Public Comments

- Comments reflect varied opinions about regional cost share issue
 - Consistent with task force findings
 - Consistent with previous Council discussions
- Council's wastewater customers (i.e., cities) either can support Alternative 3 (cost share based on wastewater system benefits) or have provided comments on what they would want to see if Council proceeded with Alternative 3
- For pilot program, projects under consideration could proceed equally well under Alternative 2 (cost share based on environmental and economic benefits) or Alternative 3
- Given Council's Thrive principles, staff recommend policy based on Alternative 3 (see handout)



Recommended Policy



Staff recommend a wastewater reuse pilot program with a cost share component based on wastewater system benefits (Alternative 3) – see handout
