### **Proposed Action**

That the Metropolitan Council authorizes its Regional Administrator to negotiate and execute an intergovernmental agreement, Contract 22I007 with Hennepin County for the construction of temporary conveyance as part of Hennepin County's Noerenberg and Hendrickson bridges replacement project for an amount not to exceed \$2,300,000.

#### Background

Hennepin County is replacing Hendrickson and Noerenberg Bridges along CR 51. The existing 8567 forcemains are currently suspended from each bridge and must be removed. MCES is collaborating with Hennepin County to include the temporary conveyance to be installed before their bridge demolition is initiated. A separate project will relocate the permanent replacement forcemains under the Lake Minnetonka channels.

# Rationale

Intergovernmental agreements with an agency exceeding \$500,000 require Metropolitan Council authorization per Council Expenditure Policy 3-3.
