



Factors impacting housing options

- Household size and composition
- Cultural preferences
- Substance use/chemical dependency
- Mental Health, Serious Persistent Mental Illness
- Criminal background
- Availability of slots

Same Population / Different Programs

Mainstream


- Non-elderly
- Disability required
- 3 year look back for violent criminal and drug offenses
- No case management requirement
- HAT Partnership
- 253 vouchers no sunset

Emergency Housing Vouchers


- 18+
- No disability requirement
- Certain eligibility criteria are waived
- One year of case management required
- Referrals = Coordinated Entry
- 218 vouchers sunset in 2023

Housing Search Increases Success for Highest Barrier Families



Service Providers



- Case management for at least one year
- Determined by the referral partner
- Depends on the client
- Address holistic needs of families
- Trust building is key

Limited housing options



In a competitive housing market...

- Few housing providers will work with highest barrier families
- Certain neighborhoods are unaffordable
 - Zero Income households
- Very low supply of deeply affordable housing
- High turnover of property managers

Approved Funding Categories

CARES \$1205 Avg

- Moving Expenses
- Debts owed for lease up (tenant readiness)
- Application fees
- Security Deposits

\$1312 Avg


- Above plus...
 - Transportation for housing search, TAP Cards and cabs only
 - Utilities
 - Essential household items
 - Renter's insurance
 - Property owner incentives

MS5 \$1073 Avg

- Above plus...
 - Transportation, cabs and TAP cards
 - Rent

What's Working

- Relaxed program screening criteria
- Flexibilities and support once admitted
- Case management for at least one year
- Funding for move-in and housing stability expenses

Takeaways



What's Needed

- Funding for move-in and housing stability
- Housing affordable to people at very low incomes
- Supportive housing
- Landlord motivation to accept vouchers
- Ongoing case management
