## Statute Requires Development Guide

Metropolitan Land Planning Act (Minn. Stat. 473.145)

The Metropolitan Council shall prepare and adopt, after appropriate study and such public hearings as may be necessary, a comprehensive development guide for the metropolitan area...

## Statute Requires Development Guide (2)

#### Metropolitan Land Planning Act (Minn. Stat. 473.145)

... It shall consist of a compilation of policy statements, goals, standards, programs, and maps prescribing guides for the orderly and economical development, public and private, of the metropolitan area. The comprehensive development guide shall recognize and encompass physical, social, or economic needs of the metropolitan area and those future developments which will have an impact on the entire area including but not limited to such matters as land use, parks and open space land needs, the necessity for and location of airports, highways, transit facilities, public hospitals, libraries, schools, and other public buildings.

- Center equity in the process of developing the 2050 RDG
- Center equity in the policies of the 2050 RDG
- Define equity for the 2050 RDG planning process to create shared understanding

## **Equity Framework Project Examples**



## **Housing Investment in Western and Southern Twin City Suburbs**

- Project Description: CURA is working with various governments and community-based organizations on a research agenda to focus institutional investment in the housing market and its impact on tenants. Primarily, this work is being used to identify existing and potential tenant stabilization policies in the western and southern Twin Cities suburbs, increase government transparency around rental licensing data, and spatial analysis to more accurately measure the scope of the various issues
- Geography: Edina, Eagan, Bloomington, Minnetonka, St. Louis Park, and Richfield
- Government Partners: various city governments in project geography
- Community Partners: various advocacy organizations in project geography, including Jewish Community Action, Homeline, and the Alliance for Metropolitan Stability
- Framework: centering conversation on the voices and experiences of tenants and community-based organizations to impact housing policy discussions in various jurisdictions

## **Equity Framework Project Examples**



#### **Blue Line Extension Anti-Displacement Project**

- Project Description: CURA worked with various partners to study they types of policies that could prevent housing, business, cultural, and displacement in the Blue Line Extension corridor as the result of implementing the Blue Line Extension
- Geography: Hennepin County, Minneapolis, Crystal, Robbinsdale, Brooklyn Park
- Government Partners: Met Council, Hennepin County, Minneapolis, Robbinsdale, Brooklyn Park, Minneapolis Parks and Recreation Board
- Community Partners: various advocacy organizations, business organizations, philanthropic partners, and members in community
- Framework: broadened the scope of project considerations beyond transit and recentered Blue Line Extension corridor communities to create vision for ensuring they are the primary benefactors of the work
