

Metro Area Transportation Sales Tax Overview



New, sustainable revenue for regional transportation

³/₄-cent sales tax for metropolitan transit, starting Oct 1, 2023
17% to counties for services including transit ~ \$88 million in CY24

83% to Metropolitan Council

5% to active transportation (to be determined by TAB) 95% to transit operations, maintenance, capital projects

Expected revenue to the Council

- About \$400 million forecast in CY2024 for Council transit activities
- 3% growth rate will be assumed in budget forecast
- Growth rate reviewed annually

Sales Tax Legislative Requirements

Improvements to ...

- Regular route bus service levels
- Public safety on transit
- Accessibility at transit stops and transit centers
- New, replacement shelters

Bus Rapid Transit

Planning and project development

• Operations, capital maintenance

And other investments

- Zero emissions bus transition
- Micro transit (all transit providers)
- Active transportation
- Wage adjustments for hourly operations employees

Other impacts

- Addresses operations deficit previously forecasted to begin in SFY2026-2027
- Ends counties' responsibility for transitway operations funding on October 1, 2023
- Clarifies Metropolitan Council is responsible for all capital maintenance costs


Transportation Sales Tax Opportunities



30-Year Projection Preliminary Results

- Financial review provides understanding of obligations and opportunities.
- Enables operation and long-term upkeep of existing transit system and 2030 METRO lines
- Opportunity to develop a new transit system vision with Council, providers, partners and community

Concurrent Process for 26-Year Transportation Funding Plan

26-year Revenue and Expenditure Forecast Thru 2050

- All transportation revenues including MnDOT, local governments, transit
- Substantial expansion in revenues from 2040 TPP; requires greater collaboration for planning investments
- Focus on major projects (e.g., transitways, highways)

Key Differences in Transit Assumptions

- Assumes Riverview transitway in funded plan (mode/alignment planning update underway)
- Baseline will assume 3% growth for MVST and Sales Tax; will also include estimates for higher growth rates
- Financial estimates include all transit providers

Metro Transit Visioning and Strategic Planning

Metro Transit Forward

- Opportunity to co-create a shared vision and updated strategic plan for Metro Transit service delivery and shape future budget development
- Will build on initiatives in the current strategic plan. For example:
 - Network Now
 - Safety & Security Action Plan
 - Great Workplace Project
 - Metro Transit's contributions to the Council's Climate Action Work Plan
- Will align with regional development guide, TPP, Council's strategic plan, and other Council policies
