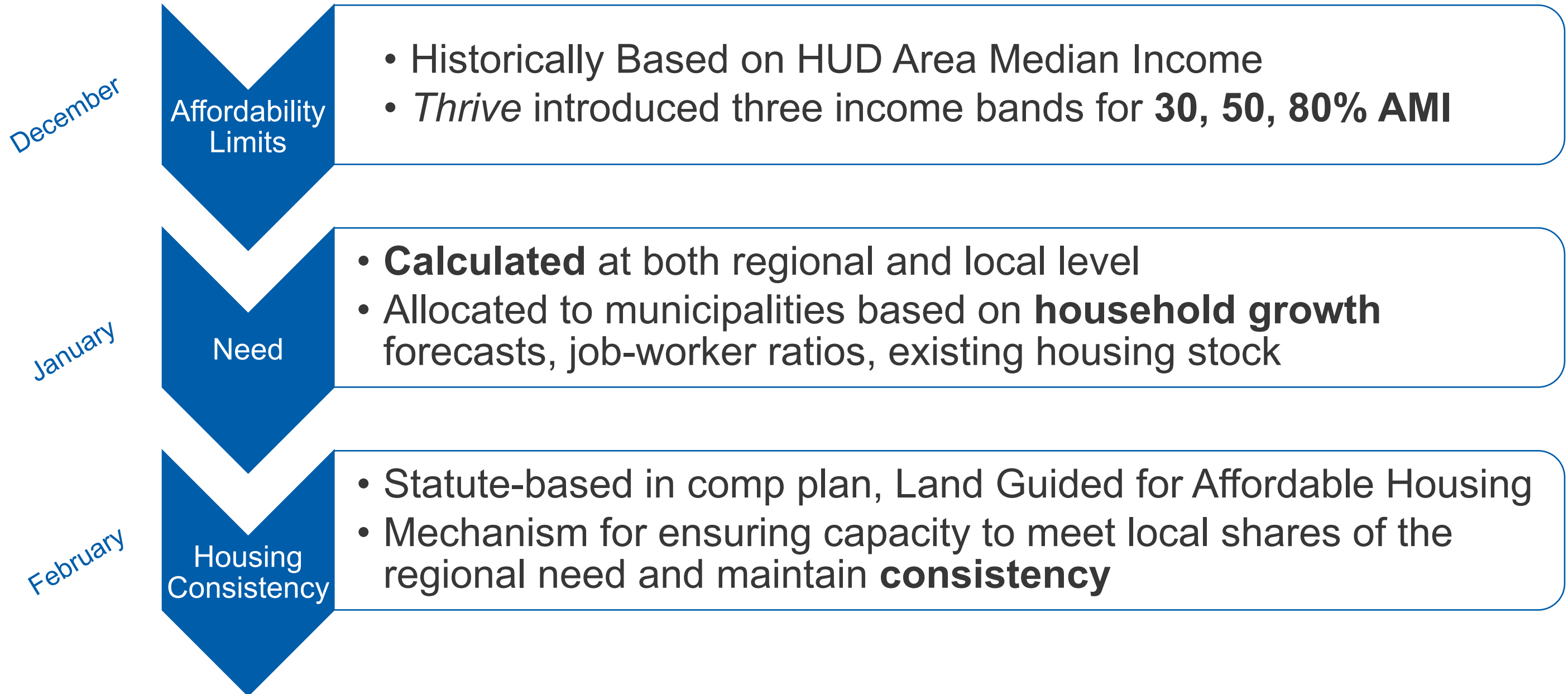

# TAG Items of Consensus



- Continued policy and funding priority on deeply affordable (30% AMI) (top 5 priority)
- Policy goal: Wealth-building opportunities for low-income households, with a focus on ending racial disparities, acknowledging a majority of renter households of color fall into the 40-80% AMI range, should be emphasized (ownership and shared ownership focus)
- Rental and Ownership Need Numbers Distinct (ownership offered, not used for consistency, and sent separate from the system statement “supplemental housing data”)

# TAG Items of Consensus

- Differentiate what can be land use and market driven vs a policy goal that is supported by government funding/intervention
- Be very clear about any alternate measures of affordability, why, when it is used, and publicized in a way not to confuse anyone
- The Metropolitan Council focusing on their own investments for anti-displacement policy is a good first step, follow up with best practices for local level investments
- Provide localized median incomes, do not use for consistency



# TAG Items of Consensus



- Everyone in the metro should have housing that is stable and affordable (30% of income) to them
- Consider housing infrastructure as part of an interconnected system people need to thrive in our region (jobs, education, daycare, health, transportation, food, mental health, supportive services, ect)
- Explore the use of midpoint densities for tracking local community housing consistency in the 2031-40 decade\*
- Create an alternate measure of affordability but keep HUD as the standard for funding to better reflect the reality of residents in the region. (25% of income)\*

# Draft Housing Policy Plan Objectives

## Objective

### CULTURAL CONNECTION & WELL-BEING

Everyone has access to homes, not just housing

### EQUITY

Repair historic and ongoing injustice in housing practices and outcomes

### ENVIRONMENT

Housing in our region is resilient to climate change impacts and furthers environmental justice

## Policy

Increase the ability for residents to keep their homes, amenities, health and/or sense of belonging in a neighborhood.

Limit the effects of historical injustices through reparative and community-centered action, and limit future disparities by shifting current policies to protect communities whose disparities are largest.

Support the development and maintenance of homes to create a climate resilient future.

## Actions

Prioritize cultural connections in funding criteria

Our housing investment strategy involves community engagement well before neighborhood impacts are felt at the local level, incorporate mitigation strategy in the planning process

In areas where they are not already, including utility costs in affordability limits

# Draft Housing Policy Plan Objectives

## Objective

### OPTIONS TO OWN OR RENT

Rental and ownership options are available to all households regardless of income

### DECENCY

Affordable housing is built to a high standard and maintained, safe, and accessible for all residents

## Policy

Support and incentivize development, preservation, and maintenance of affordable housing units, of all types and tenure (rental, shared equity and ownership), that reflect the true cost-burden experienced by residents.

Support and incentivize development, preservation, and maintenance of affordable units of all types that provide residents a safe, dignified and healthy place to live. Assist and prevent loss of affordable housing that reaches the end of the affordability requirements. Support the development of more accessible units and universal design.

## Actions

Present HUD/LIHTC affordability limits alongside measure that reflects experience of our regions' residents

Fully fund Affordable Homeownership (LCA) to reach more people

Inform State Building Code rewrite

Fund preservation with parity to new development

# Draft Housing Policy Plan Objectives

## Objective

### FAIR HOUSING & GEOGRAPHIC CHOICE

People regardless of ability, age, financial status, race, and family size, can live in a community they choose

### STABILITY

Safe, affordable, and dignified places to live are available to everyone, especially those experiencing housing insecurity and homelessness

## Policy

Develop policy, provide resources and funding, and support local, regional, and state initiatives that increase the ability for households to choose where to live in the region regardless of ability, age, financial status, race, or family size.

Develop and support local, regional, and state policy that makes it less likely for residents in the region to experience housing instability and homelessness, with focused support for people who are experiencing homelessness and housing insecurity currently.

## Actions

Affordable Housing Need Allocation to all sewer-served Communities

Continue to fund fair housing trainings for local level staff

Participate with partners in the Metropolitan Interagency Council on Homelessness

Support housing efforts of groups that assist people in substance abuse recovery
