

Our region meets the opportunities and challenges faced by our communities and the economy including issues of choice, access, and affordability.


### **We Lead on Addressing Climate Change**



# Metropolitan Parks and Open Space Commission Advice

November 2023, January and February 2024 meetings

## A Range of Ideas

- Create **flexible regional standards for community engagement**, including expectations to engage people outside service area/jurisdiction.
- Promote **consistent wayfinding and signage** across system.
- Create new policy around **communication and marketing** of our high-quality system. Promote **public awareness** of the system.
- Create **sustainable approach to fund system**. Can we achieve what's currently included in the system plan? By when?
- Address **water quality** and **availability**. How to best inform people of issues like PFAS?
- **Rethink regional trails** as more than just a place to bike. Provide more park-like amenities in corridors that have more space.



# Implementing Agency Partner Advice

## Jan. 18, 2024 – Discussion of Draft Parks Objectives

### Equity Ideas

- Streamline equity analysis and public engagement requirements
- Strengthen tribal relationships, co-management of parks and trails
- Decriminalize park ordinances

### Regional Parks and Trails System Plan Ideas

- New cultural landscape classification idea
- New natural system/open-space classification idea

### Climate Mitigation and Adaptation Ideas

- Promote regional trails as GHG reduction strategy, recognize as arterial backbone of an active transportation network.
- Use trail corridors to protect and connect habitat and wildlife.
- Create multi-jurisdictional Climate Action Plans


## Jan. 18, 2024 – Discussion of Draft Parks Objectives

### Natural Systems Ideas

- Emphasize lands with restoration potential, including former industrial landscapes.
- Designate lands in low-service, low-wealth, high BIPOC areas.
- Convert abandoned railroad corridors to regional trails.

### Recreation Activities and Facilities Ideas

- Expand allowable activities and facilities in regional parks and trails to meet emerging needs.
- Balance flexibility with desire to retain our natural system foundation.
