Build support for co-creation



Process development and approval

- Council policymaker conversations
- Contracted support with CURA staff for extra capacity and support with strategies and approach
- Outlined proposed Advisory Council to RDG WG
 - Received approval for process in December 2023
 - Strong support for approach which included cocreation, development of actions, and Council commitments for inclusion into *Imagine 2050*.
- Effort to be led by indigenous community, staff, and policymakers

American Indian Advisory Council

Respected elders and Community leaders

- 12-15 community leaders representing a range of tribal affiliations and community organizations
- Bi-monthly meetings for four months to develop a statement of commitment with accompanying actions
- Review *Imagine 2050* policies and actions to ensure integration of indigenous voices and community needs







Build community trust



From land acknowledgment to Council commitments

- Inclusion of land, water, and people (all)
- Recognition of past harm
- Representation and partnership in decisionmaking
- Access to sacred sites
- Support for community-based organizations and culturally-responsive services
- Safe, affordable, welcoming neighborhoods
