1. 2025 Bus Rapid Transit Openings & Readiness Updates (Lesley Kandaras, Alicia Vap, Andrew Brody, Jonathan Ahn, Adam Harrington, Liz Jones, Katie Roth, Frank Alarcon, Adam Smith, Marilyn Porter, Chief Dotseth, Maria Cone)

Lesley Kandaras, General Manager of Metro Transit, introduced the presentation on three METRO bus rapid transit lines (Gold Line, B Line and E Line) opening in 2025.

For all three bus rapid transit lines, lead staff provided an overview of funding and agreements, construction partnerships, project status and operational readiness. For the METRO Gold Line, staff shared an overview of the marketing and outreach efforts leading up to the opening day on March 22, 2025. The METRO B Line is scheduled to open on June 14, 2025 and the METRO E Line is scheduled to open on December 6, 2025.

For presentations on each bus rapid transit line, Council members asked about ridership data, community outreach and engagement efforts. Council members commended staff for their outreach work to connect with impacted residents and businesses throughout the project phases. In addition, Council Members Johnson and Lilligren requested the statistics shared by General Manager Kandaras on the expansion of the bus rapid transit lines.
