

Uses by Department




Uses by Category






CD –**Operating Budget Comparison**



CD Capital Program

- 2015 CIP will be presented to Council in October
 - Will add planned capital spending for 2020
 - Will remove completed projects from authorized
 - Will assume same level of regional bonding (\$7M/yr) and state bonding (\$11M per biennium)
 - Will assume higher Parks and Trails Legacy funding than in 2014
 CIP (\$16.4M/yr versus \$14.4M/yr)
 - Will assume \$5.2 M of regional bonding not needed to match State funds finances new grant program to strengthen equitable use of Regional Parks System (2040 Regional Parks Policy Plan)
