## Background

The 2014 Regional Parks Capital Improvement Program (CIP) is financed with 2014 State bonds and Metro Council bonds. The CIP proposed that $\$ 11$ million of State bonds be appropriated and matched with $\$ 7.33$ million of Metro Council bonds. However, only $\$ 4$ million of State bonds was appropriated which in turn is matched with $\$ 2.66$ million of Metro Council bonds. With reduced funding, each park agency's share of the CIP was reduced in proportion to the reduction. Each park agency's share included a prioritized project list. With the reduction in funding, projects are fully funded in priority order until all funds are allocated.


The Minneapolis Park \& Recreation Board had three projects in its allocation. The Park Board has requested a minor amendment to the CIP which would partially fund its second and third priority projects at different amounts than what has been proposed in the CIP. The Park Board's request is based on the Park Board's resolution approving amendments to the FY2014 and FY2015 Regional Park Capital Funding Allocations as shown in Attachment 1.

The following table illustrates the CIP amount the Park Board wants to spend for each project.

## Rationale

This minor amendment effectively uses the MPRB's allocation in the CIP by funding portions of all three projects instead of not funding the third priority project. Approval of the minor amendment allows the Metro Council to use the amended list to award grants for the projects when conditions for those grants are met.

## Funding

The funding for this minor amendment is from a portion of the 2014 State bond appropriation of $\$ 4$ million and $\$ 2.66$ million of Metro Council park bonds. The MPRB's total grant amount does not change-only the amount per project changes.

Attachment 2 illustrates the 2014 Parks CIP as funded at $\$ 4$ million of State bonds and $\$ 2.66$ million of Metro Council bonds.

## Known Support / Opposition

The Minneapolis Park \& Recreation Board supports this minor amendment. There is no known opposition to this minor amendment. The Metropolitan Parks and Open Space Commission unanimously approved the recommendation on July 1, 2014.

## Resolution Approving Amendments to the FY2014 and FY2015 Regional Park Capital Funding Allocations

Whereas, The Minneapolis Park \& Recreation Board (MPRB) is the steward of the Minneapolis park system;

Whereas, The MPRB seeks to secure funding for capital improvements to Minneapolis parks to meet the needs of park visitors;

Whereas, The MPRB approves a 6-year capital program on an annual basis based on projected and historic funding levels from local and state sources;

Whereas, Parks and Trails Legacy Fund allocation for FY 2015 will become available on July 1, 2014 and the Metropolitan Council is developing grant agreements with regional park implementation agencies for the FY 2015 allocations;

Whereas, The State and Metropolitan Council Bonds for FY 2014 will become available on July 1, 2014 and the Metropolitan Council is developing grant agreements with regional park implementation agencies for the FY 2014 allocations;

Whereas, The state legislation that authorized the Parks and Trails Legacy Fund allocation included language for funding trails in Theodore Wirth Regional Park at some amount as part of the MPRB's allocation;

Whereas, The FY2014 Bonding Bill included less funding for regional parks than anticipated, resulting in the MPRB receiving $\$ 1,361,000$ versus $\$ 3,742,000$;

Whereas, The MPRB capital allocations for regional parks for FY 2014 and 2015 must be amended to account for the Parks and Trails Legacy fund legislation and the approved level of State and Metropolitan Council bonding for regional parks;

Whereas, Project phasing and existing funding commitments have been considered in developing the amendment recommendations for FY 2014 and FY 2015 regional park capital allocations (Exhibit 1); and

Whereas, This resolution is supported by the MPRB 2007-2020 Comprehensive Plan, which envisions "Dynamic parks shape city character and meet diverse community needs;"

RESOLVED, That the Board of Commissioners approve the recommended amendments to the


FY 2014 and FY 2015 regional park capital funding allocations; and
RESOLVED, That the President of the Board and Secretary to the Board are authorized to take all necessary administrative actions to implement this resolution.

SUBJECT: Resolution Approving Amendments to the FY2014 and FY2015 Regional Park Capital Funding Allocations

## BACKGROUND

This action modifies the FY 2014 and 2015 regional park capital program to account for the smaller state and Metropolitan Council bond allocation the Minneapolis Park and Recreation Board (MPRB) will receive based on current legislation, and language in the authorizing legislation for the Parks and Trails Legacy Fund. The MPRB's capital program anticipated $\$ 3,742,000$ million and the MPRB will receive $\$ 1,361,000$ million. Additionally, the authorizing language for the Parks and Trails Legacy Fund specifically identified Theodore Wirth Regional Park trails as a project to be funded at some level. Approving this amendment will allow the MPRB to enter into grant agreements for its Parks and Trails Legacy Fund and State/Metropolitan Council bond allocations with the Metropolitan Council.

The following goals drive the recommended changes to the 2014 and 2015 regional park allocations that are outlined in Exhibit 1:
a. Retain sufficient funds to fully fund the trail and overlook improvements at Ridgway Parkway.
b. Retain funding to partially meet contractual obligations with the City of Minneapolis for the parkway paving and lighting projects.
The amendment to the capital program will result in the following project changes:
Above the Falls Regional Park - Funds allocated to this park are currently focused on the implementation of Hall's Island, as one of the top priority projects identified through RiverFirst. To account for less funding being allocated to the project in 2014, additional funds will be recommended in future years of the capital program for Board consideration.
Theodore Wirth Regional Park - The funds would be used to further trail improvements currently planned for the park. This is consistent with the top priority projects recommended by the former Community Advisory Committee for the park..
Parkways - Funds for parkways is an ongoing allocation within the MPRB's capital program. The reduction in funds in this category will result in the following parkway segments that were scheduled to be renovated in 2014 to be delayed to future years:

Cedar Lake Parkway - R\&R Bridge north to 394 and Theodore Wirth Parkway - between Plymouth Avenue and the Bassett Creek Bridge. In addition, segments of Theodore Wirth Parkway that were to be sealcoated in 2014 will be postponed to future years.
The Metropolitan Council enters into grant agreements with regional park implementing agencies for the Parks and Trails Legacy Funds and bonding funds that are allocated to the Metropolitan Regional Park System. The amount each agency receives is based on formulas that have been developed collectively by the agencies. These formulas rely on several factors, including acreage, visitation and population size, to determine funding allocations.
The Met Council's Metropolitan Parks and Open Space Committee meets on July 1 to approve 2014/2015 bonding projects and to include them in the Metropolitan Council's third quarter unified budget amendment on August 27. If the MPRB approves this action and wishes to make the deadline for the August unified budget amendment, it would need to approve this action at committee and full board on June 18.
