### Background

The Council is required by Minnesota Statute 473.147 to prepare and adopt a long-range system policy plan for regional recreation open space as part of the Council's Metropolitan Development Guide. The Council has consulted with the Metropolitan Parks and Open Space Commission, regional park implementing agencies, other partners and stakeholders, and the general public as part of the development of the draft *2040 Regional Parks Policy Plan*, which builds from the policy direction provided in *Thrive MSP 2040*. The draft plan was released for public comment on August 27, 2014. The public record will remain open until 5:00 p.m. on Thursday, October 30, 2014.

The public comment period and public hearing will offer partners, stakeholders, and the public an opportunity to formally comment on the draft *2040 Regional Parks Policy Plan*.
