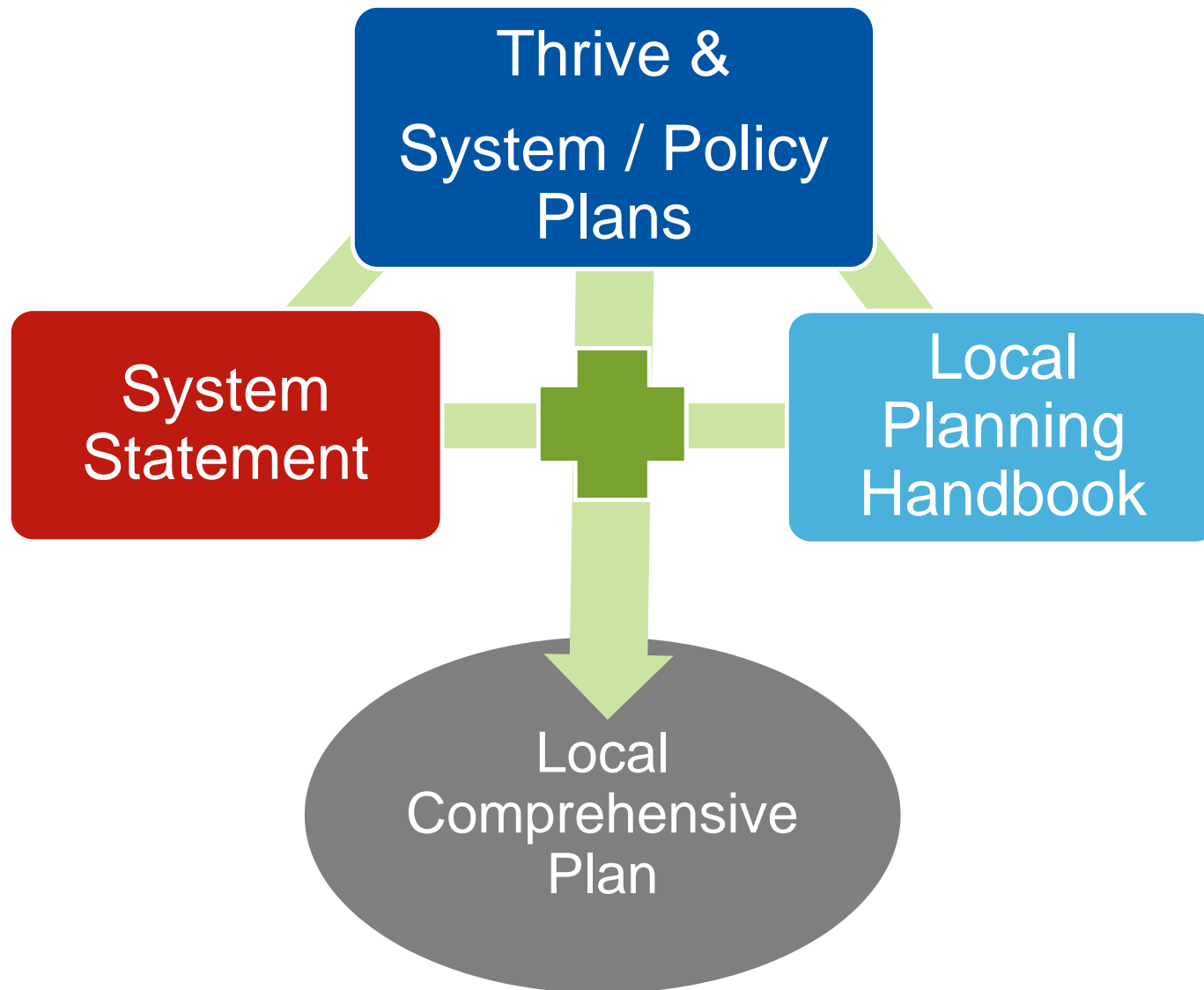

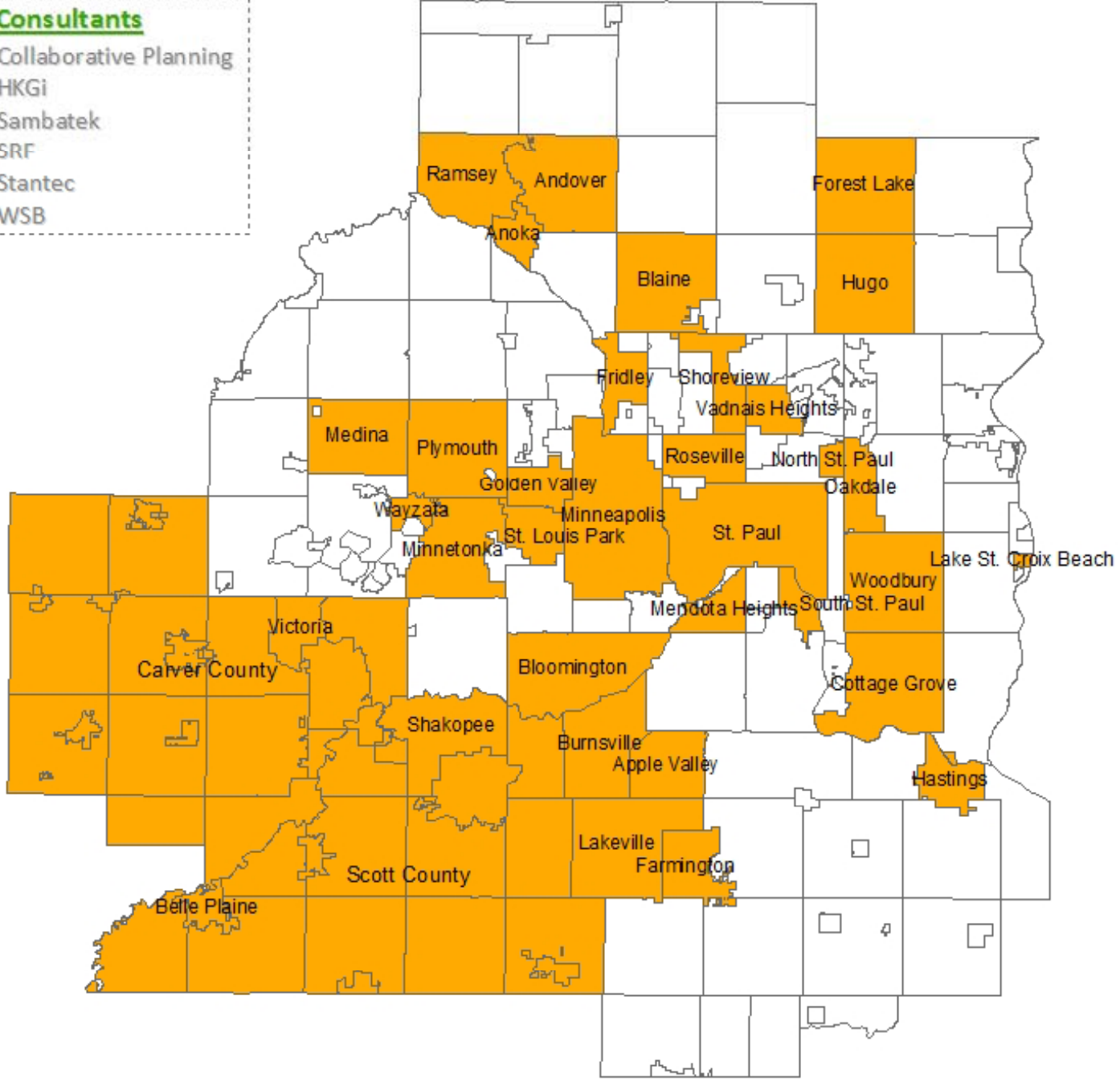

(A.K.A. A week in the life)

- Internal and external web navigation testing nearly complete.
- Evaluating comments and identifying fixes from external testing.
- External content review of Introductions, Land Use, Housing and Implementation text sections to be complete May 8th.
- Preparation of external Transportation Content review to roll out May 8th.
- Preparation of internal review of Online Registration, Online Submittal, and Interactive Mapping Tools to be held May 7th.
- Development of instructions and resources needed to test the tools, but also developing test questions, scenarios, and instructions for upcoming test topics on May 7th.

- Compile comments
- Identify needed fixes, revisions, rethinking
- Set schedule for fixing issues
- After all mid point testing is done, we will be **RETESTING** all changes in August before rollout to get confirmation from our primary users – our external focus group, that the changes made address issues, and clarify content, and provide an overall guide to local comp plans that provides real and useful assistance
- Results of all testing will be reported out at an upcoming CDC meeting.
