## **Proposed Action**

That the Metropolitan Council amend its local forecasts and Allocations of Affordable Housing Need for Prior Lake and Shakopee, as shown in Attachment 1.

## **Background**

Metropolitan Council's forecasts provide a reference as the Council and other governments prepare plans addressing areas and populations to be served, as well as the levels, distribution and staging of services (Minn. Stat. 473.146). Metropolitan Council approved local forecasts with the *Thrive MSP 2040* plan on May 28, 2014; the Council revised those forecasts on July 8, 2015.

The tribal government of Shakopee Mdewakanton Sioux Community (hereafter SMSC) and the cities of Prior Lake and Shakopee have requested that Metropolitan Council amend its local forecasts, so as to count and project employment, population and households, taking into account the tribal holdings and the resulting planning impacts for Prior Lake and Shakopee. Metropolitan Council Members Barber and Wulff and Council staff met with tribal government and city officials in order to understand and clarify the planning challenges for these communities.

The proposed action includes the following:

- Metropolitan Council amends its local forecasts to include forecast information from SMSC, reflecting the tribal government's expectations of community growth.
- Metropolitan Council amends its local forecasts for Prior Lake and Shakopee, reducing the employment, population and households to fit within the land supply in the balance of Prior Lake and Shakopee, after separating out the tribal area.
- Metropolitan Council adjusts the Allocations of Affordable Housing Need for Prior Lake and Shakopee to reflect the amended forecasts.

Prior Lake and Shakopee will use the amended forecasts in their preparation of 2040 comprehensive plan updates.

SMSC and the two cities have agreed to define the tribal area, for planning purposes, as the current trust lands and fee lands held by SMSC. The 2010-2040 forecast for this area, prepared by SMSC and Metropolitan Council staff working together, reflects the tribal government's expectations of community growth.

#### **Rationale**

Shakopee Mdewakanton Sioux Community (hereafter SMSC) is a federally recognized sovereign nation. Its trust lands are generally not subject to the civil regulatory authority of states, counties, or cities (492 U.S. 408). This status preempts planning, zoning and related regulation of trust lands by the cities of Prior Lake and Shakopee.

SMSC and the two cities have distinctly different land use patterns and community goals. These local governments propose an explicit forecast of future growth in the tribal area. Forecasts for the balance of Prior Lake and Shakopee are reduced accordingly. This approach better represents the amount and scope of future growth being planned in the geographic areas for which each community has jurisdictional responsibility.

## **Funding**

## **Known Support / Opposition**

Council staff have agreed on the revised forecasts with the tribal government and the two cities. All have agreed that the local forecast from SMSC does not introduce nor imply any new obligation on SMSC.

There is no known opposition to the revised forecasts.
