 - "The council shall prepare an annual plan for distribution of the fund based on the criteria for project and applicant selection




Metropolitan Livable Communities Act (MS 473.25)

- Three active accounts
 - Tax Base Revitalization Account (TBRA)
 - Livable Communities Demonstration Account (LCDA)
 - Local Housing Incentive Account (LHIA)
- Separate Category of LCDA & TBRA for Transit Oriented Development (TOD)

2017 LCA Work Group

Work group of Council Members and 10 community representatives from Metro Cities

- Discussed six issues
 - o TBRA Pilot grants
 - o TBRA Site Investigation grants
 - o Land Acquisition costs for LCDA & LCDA TOD
 - o Land Acquisition holding costs for LCDA & LCDA TOD
 - o LCDA TOD Pre-Development grants
 - o LCDA & LCDA TOD award limits



TBRA Pilot (Cleanup in ACPs)

Recommendation:

- Continue, with the following criteria
 - Allow funding potential future housing, as well as commercial / industrial (uses accepted now)
 - Limit to investigation and asbestos or lead-based paint abatement (not site cleanup)
 - Expand geographic area where funding could be used, to within 100 feet of current or former ACP
 - o 25% match
 - Change the name to TBRA Seeding Environmental Economic Development (TBRA SEED)



TBRA Area-Wide Investigation

Recommendation:

Go back to single-site investigation approach



LCDA/LCDA TOD Site Acquisition

Recommendation:

 To continue, but with staff research on potential limits for some circumstances for next year



LCDA/LCDA TOD Holding Costs

Recommendation:

To continue, but with continued staff evaluation



LCDA TOD Pre-Development

Recommendation:

 To continue as is, but with continued staff research into potential for rolling applications in future years



LCDA/LCDA TOD Award Limits

Recommendation:

To continue, with no change



Other Changes

Recommendation:

- Add willingness to accept Housing Choice Vouchers as a scoring factor for housing projects
- Update definition of "Transit Oriented Development to be consistent with the Council's 2040 Transportation Policy Plan
- Refine the definition of "Placemaking"
