Livable Communities Demonstration Account Purpose:

The Livable Communities Demonstration Account (LCDA) funds development or redevelopment projects that *efficiently link housing, jobs, services, and transit* in an effort to create inspiring and lasting Livable Communities.



2018 Funding Availability

The Council approved:

- Up to \$250,000 for LCDA Pre-Development grants to be awarded in two application rounds with \$125,000 available in each Spring and Fall round
- \$1,962,996 remains from the LCDA Development program



Review Process

- November 1, 2018: the Council received three LCDA Pre-Development applications
- Applications undergo an evaluation by a staff team from the Community Development division



Recommended Award:

\$99,600

- Mixed-income and mixed-use development project
- 60 housing units with mix of market rate and affordable at 61%-80% AMI
- Proposed office space, retail space, community gathering space, and community commercial kitchen
- Requested Activities: market study, design workshop, feasibility analysis, site plan, stormwater management plan



Grain Belt Redevelopment



Recommended Award:

\$100,000

- Infill development on City-owned property
- Mixed-use and mixed-income with affordable ownership options
- Pedestrian mall through site connecting development uses and the river
- Requested Activities: Solidify conceptual design

Ford Site Redevelopment



Recommended Award:

\$100,000

- Redevelopment of 122-acre Ford site
- Mixed-use and mixed-income project with ownership housing options
- Stormwater management plan includes central water feature that serves as amenity for the development
- Requested Activities: Alternative Urban Area Review (AUAR)



2018 Funding Recommendation

- That the Metropolitan Council:
 - 1. Authorize the transfer of \$174,600 from the Livable Communities
 Demonstration Account program to the Livable Communities
 Demonstration Account Pre-Development program
 - 2. Award three Livable Communities Demonstration Account Pre-Development grants for a total of \$299,600; and
 - 3. Authorize its Community Development Division Director to execute the grant agreements on behalf of the Council
