

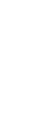


















































## **Boundaries and Acquisition**





## **Development Concept**



- Expanded access to The COR, transit network, Mississippi West Regional Park, and the Mississippi **River Regional Trail**
- Walking, jogging, inline skating and bicycling
- A 10-foot wide paved surface separated from vehicular traffic
- New pedestrian bridge
- Wayfinding signage: trail head and directional signage.
