




Regional Parks System Plan Map


Regional Trail Background

- The Council approved a 2017 grant, funded with State Bonds, to Dakota County for \$852,000 for what would become the "Mississippi River Regional Trail Construction - Rosemount".
- The grant remains unexecuted due to numerous project complexities and delays.
- The County has not used any of the funds connected with this State Bond grant.

Lake Byllesby Regional Park






Lake Byllesby Proposal

West Lake Byllesby Park Master Plan








Lake Byllesby Background

- The County seeks to change the grant scope to improvements defined in the Lake Byllesby Regional Park Master Plan approved by the Council on May 23rd, 2018
- - Dakota County has committed over \$2.57 million
 - The Council committed over \$1.12 million from Legacy Funds on July 24th, 2018
 - The Council to consider approving another \$1.277 million
 - \$852,000 currently under consideration
 - \$425,009 from State Bonds appropriated March 6th 2019







Staff Findings

- It is consistent with the 2040 Regional Parks Policy Plan.
- It is consistent with the approved master plan for Lake Byllesby Regional Park.
- The master plan has been evaluated using the Equity Toolkit.
- The Dakota County Board approved the proposed project change and funding reallocation in its 2019 Capital Improvement Program.
- The Mississippi River Regional Trail Rosemount grant is currently unexecuted and the County has not spent any funds related to this grant.

Dakota County's request meets all relevant Metropolitan Council requirements.






Proposed Action
