


### Regional Parks System Plan Map






#### Rationale for recommendation

- Consistent with:
  - The 2040 Regional Parks Policy Plan;
  - State fiscal year 2019 Parks and Trails Legacy Fund (PTLF) appropriation requirements;
  - The Blakeley Bluffs Park Reserve acquisition master plan, as amended with concurrent Business Item 2019-228; and
  - Scott County is within it's \$1.7 million-per-year limit for PTLF PAOF funding.

#### Recommendations

- Approve a grant of up to \$555,263.25 to Scott County to acquire the 37.45-acre
   O'Reilly property located at 25975 Chatfield Drive in the City of Belle Plaine for
   Blakeley Bluffs Park Reserve;
- Authorize the Community Development Director to execute the grant agreement and restrictive covenant on behalf of the Council;
- Consider reimbursing Scott County up to \$185,087.75 from its share of a future Regional Parks Capital Bonding Program; and
- Inform Scott County that the Council does not under any circumstance represent or guarantee that the Council will grant future reimbursement and that expenditure of local funds never entitles a park agency to reimbursement.
