2020 Investment Considerations - Broadly

No addition of reserves

Pro

 Allows us to build more reserves for 2021 which could be used to incorporate new ideas and programs

Con

 Doesn't provide as much funding for 2020 projects as we did for 2019 projects

Some addition of reserves

Pro

Offers more funding (as we have done in the past)
 without depleting reserves

Con

 Doesn't provide as much funding for 2020 projects as we could

Addition of all available reserves

Pro

Allows for most impact in 2020

Con

 Leaves less balance to continue to build reserves and apply to possible 2021 initiatives

LHIA Investment Options

- Council goal to spend more on affordable housing investment
- There are always more applicants/projects than funding available

2020 Authorized Budget

\$2.0M

Past Practice


+\$0.5M - \$1.0M

LCDA Investment Options

- Consistently make \$5,000,000 available for LCDA- TOD, leaving approximately \$7-8M for LCDA
- LCDA usually receives more applications than available funding
- \$5,000,000 seems "right-sized" for LCDA TOD









TBRA Investment Options

- There are often more applicants than funding, particularly clean-up funds
- Seeding Equitable Economic Development (SEED) funding also comes from this account

- Northstar Commuter Rail Line
- High frequency express routes

A 1/4-mile radius of a:

Bus stop along high frequency local bus lines

Pre-Development

A ½-mile radius of a proposed station on:

- Rush Line
- Riverview
