Background

The Metropolitan Council is required to adopt a written Administrative Plan that establishes local policies for administration of the Housing Choice Voucher program through the Council's Housing and Redevelopment Authority (Metro HRA). The Administrative Plan is the Metro HRA's main policy document that becomes an attachment to the PHA Annual Plan which is open for public comment (Metro HRA Administrative Plan).

The purpose of this information item is to have discussion and receive Committee feedback on the main Administrative Plan revisions for the upcoming year, 2021. The primary revisions include:

- Adoption of a Homework Starts with Home Preference
- Revisions to the Project Based Vouchers offer and award criteria

Homework Starts with Home (HSWH)

The suburban Ramsey Family Collaborative and Solid Ground, in partnership with suburban Ramey County school districts, received a 3-year Homework Starts with Home grant through Minnesota Housing to provide temporary rent assistance to people of underserved and under-supported populations including black, indigenous and people of color, and lesbian, gay, bisexual, transgender, queer or questioning and Intersex (LGBTQI) students and families who are homeless, doubled up (over-crowded) or at imminent risk of homelessness.

The HSWH rent assistance is temporary for 18 months. The Metro HRA is proposing to revise the Administrative Plan to include a waiting list preference, for up to 15 vouchers, to provide continued rent assistance for families to transition from the HSWH program to the Housing Choice Voucher program after the initial 18-month period is up. The project partners would continue to provide services toward success as families transition from HSWH to the Housing Choice Voucher program.

Project Based Voucher Offer and Award Criteria

The Metro HRA offers and awards Project Based Vouchers according to the criteria established in the Administrative Plan. There are revisions being recommended in how the Council awards Project Based Vouchers. The proposed revisions are intended to better align with Council housing policy priorities and with the Livable Communities Fund Distribution Plan.

The extent to which the project supports mixed income through providing a variety of units at different income levels.	5

Rationale

The Homework Starts with Home program aligns with a 2020 and 2021 Metro HRA goal to develop investment in place strategies. The revised Project Based Voucher award criteria better align with Council priorities and current goals.
