



Planned Residential Density






Existing Land Use

Proposed Action

Authorize the City of St. Paul Park to place its 2040 Comprehensive Plan into effect.

Advise the City to:

- Provide to the Council the date the City adopted the final LWMP, and a copy of the final adopted LWMP that will be included in the Plan document that the City adopts, if it differs from the draft January 2018 version contained in the last Plan submittal.
- Implement the advisory comments in surface water management.
- Advise the City to adopt the MRCCA Plan within 60 days after receiving final DNR approval, and submit a copy of the final adopted plan and evidence of adoption to the DNR, Council, and National Park Service within 10 days after the adoption.
