### PHA Plan

- Required by U.S. Department of Housing and Urban Development (HUD) for any agency administering the Housing Choice Voucher (HCV) and Public Housing Program
- Serves as a guide and informs HUD, program participants and the general public of the HRA mission for serving the needs of low-income families and strategies for addressing those needs



### PHA PLAN

#### Five Year Plan

- Submitted every 5<sup>th</sup> year
- Approved 2020-2024

#### <u>Purpose</u>

 Provide HUD long range goals for meeting the needs of low-income persons in the region

#### **Annual Plan**

Submitted each year

#### **Purpose**

- Provide HUD strategies for meeting housing needs in the coming year
- Communicate elements of the plan that have been revised



### **HCV Administrative Plan**

#### What is the Administrative Plan?

- Required by HUD
- Main policy document
- Contains all mandatory and discretionary policies
- Supporting document to the PHA Plan
- Must be available for public review

#### **Examples of Policies**

- Selection and admission from the waiting list
- Voucher issuance
- Occupancy policies
- Subsidy standards
- Informal hearing procedures
- Inspection guidelines and performance standards




## Resident Advisory Board (RAB)

#### **RAB Elements**

- Make recommendations regarding the proposed policy changes
- Membership consists of individuals who reflect program participants
- Serve as focus groups to help shape and guide policy development, process improvement and customer service delivery

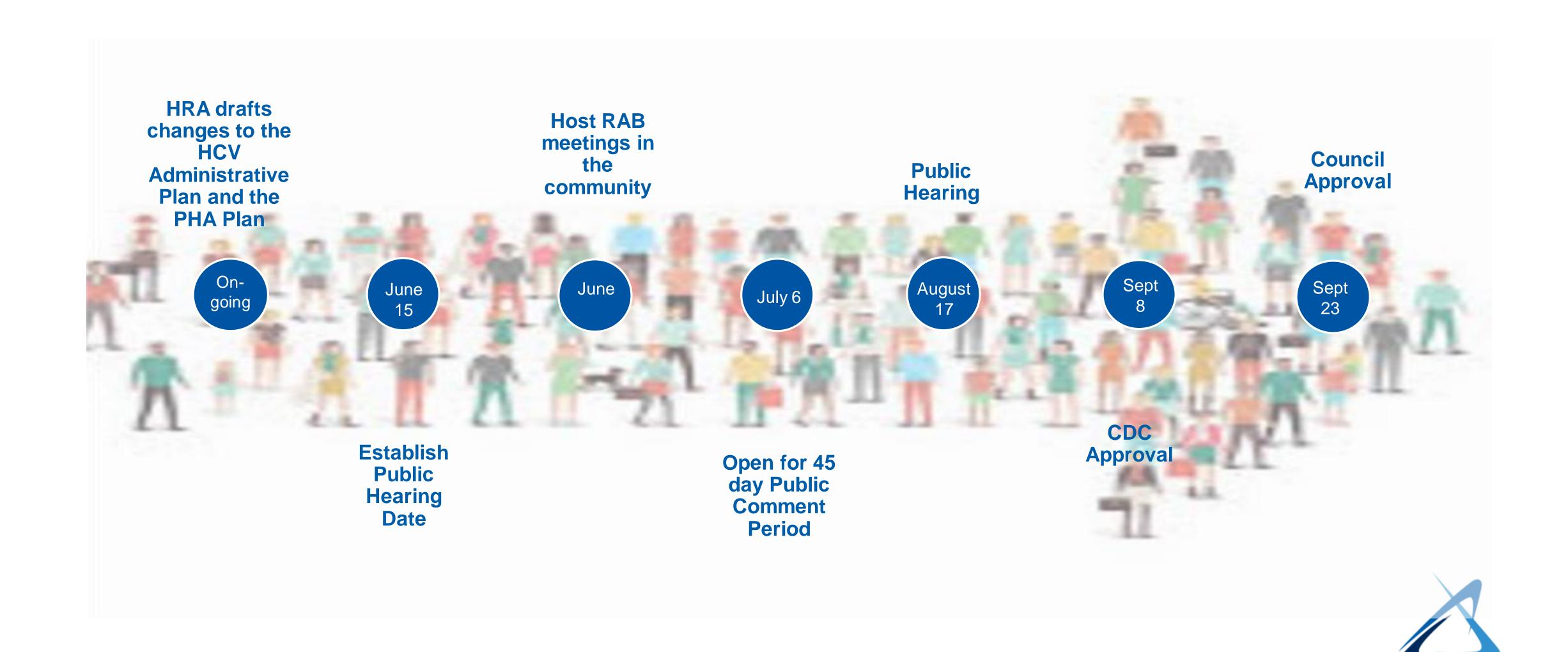
#### 2020 RAB Engagement
