Proposed Action

Background

In preparation for upcoming work planning discussions for the Community Development Committee, Council staff will report out on the work that the Committee accomplished in 2021, provide a status update on ongoing projects, provide an update on efforts related to the Council's Housing Goal identified in the <u>Metropolitan Council Strategic Plan</u>, and provide an update on this year's Metro HRA activities. Council staff will also seek feedback from the Committee on prioritizing efforts in 2022 to ensure that staff work plans are aligned with Committee expectations.

The Committee's 2021 work plan identified regular business items, such as review of comprehensive plans and plan amendments, as well as a number of initiatives in 2021. As shown in Table 1 below, we had planned for a number of initiatives, some of which we have brought to this committee, some of which we brought to the Committee of the Whole, and others that are still underway. Table 1 at the end of this report summarizes those efforts.

Updated information on the status of the Housing Strategies are detailed in Table 2 at the end of this report. Many items are incorporated as part of the division staff's regular work (labeled "Ongoing"), while several special projects and initiatives were incorporated into the CDC's annual work plan.

In addition to reporting out on the status of planned work and activities for the Committee, Metro HRA staff will provide an end of year update on program activities. There have been a number of new initiatives that the HRA has taken on this year. While we have reported to you at the start of each of these initiatives, staff will provide a consolidated report at the Committee's meeting.
