




Background

- Thrive 2040 and the 2040 Regional Parks Policy Plan
 - Strengthen equitable use of regional parks and trails across age, race, ethnicity, income, national origin and ability
 - Create and fund a competitive equity grant program for projects that strengthen equitable use of the Regional Parks System
- 2019 Pilot Program
 - \$300,000 available for capital projects
 - 3 of 15 applications funded
 - Demonstrated a great need for more funding, especially programming funds






2021 Funding Amounts

• \$2,064,000 available


- \$664,000 in Council bonds for capital projects
- \$1.4M in parks interest earnings prioritized for non-capital, programming projects
- Funding limits:
 - \$200,000 per agency from Council bonds
 - \$200,000 per agency from interest earnings





Applications and Review Process

- All 10 Regional Parks Implementing Agencies
 submitted applications
- 37 applications total, requesting \$3.8 million
- Review team scored the applications and met on May 14 to develop funding recommendations
 - Members from the Metropolitan Parks and Open Space Commission, Community Development Committee, Equity Advisory Committee, and Implementing Agency staff
- 23 projects recommended for funding, for a total of \$2,054,000

Takeaways from the Review Committee

- Overall, really impressed with the applications, especially the programming and blend of capital and programming
- Funding programming is a priority- use interest earnings for programming
- Agencies have other funding for capital projects
- Accessibility projects need to go beyond ADA requirements
- Proposals that scored high seemed to be developed specifically for the equity grant program, versus trying to fit existing projects into this program (such as capital projects that are already in an agencies capital improvement plan)
- Top projects were those with strong community engagement and partnerships
- Would like to see a more diverse representation of the community involved in the design of the projects
- Concerns around hiring BIPOC staff at low pay (temporary, part-time, etc.) doesn't help towards equity
 unless there is a pathway towards permanent
- Funding needs to go beyond the urban core





Recommended Action

- That the Metropolitan Council:
- 2. Authorize the Community Development Director to execute the grant agreements on behalf of the Council.

1. Approve funding 23 projects totaling \$2,054,000 for the Regional Parks System 2021 Equity Grant Program, as shown in Table 1 of the report.
