2021-295 City of Ramsey Lynwood Subdivision Comprehensive Plan Amendment, Review File 21819-2

Planning Analyst Eric Wojchik presented the Business Item to the Community Development Committee.

It was moved by Lee, seconded by Wulff, that the Metropolitan Council adopt the attached Review Record and take the following actions:

- 1. Authorize the City of Ramsey to place its comprehensive plan amendment into effect.
- 2. Find that the amendment does not change the City's forecasts.
- 3. Find that the amendment renders the City's comprehensive plan inconsistent with the Council's housing policy, and that the City is therefore considered "not in good standing" for the purposes of the Livable Communities Act (LCA) programs.
- 4. Advise the City:
 - a. To be consistent with Council housing policy, the City needs to re-guide additional acres expected to develop in the 2021-2030 decade to a land use with a minimum density of 8 units per acre or raise the minimum density of an existing land use to 8 units per acre to accommodate a minimum of 233 additional units.
 - b. To implement the advisory comments in the Review Record for land use and housing.

Motion carried.

The Community Development Committee recommended approval of the proposed action without questions or discussion.

2021-308 Payment Standards for Metro HRA Rent Assistance programs Metro HRA Director Terri Smith presented the Business Item to the Community Development Committee.

It was moved by Vento, seconded by Lindstrom, that the Metropolitan Council adopt payment standards as shown in Table 1 for the Housing Choice Voucher and other rent assistance programs effective January 1, 2022.

Motion carried.
