

2021 Process criteria – Step One

- Address or identify a specific residential and/or workforce community need that was identified in consideration of those least represented and most impacted by current and historic racial inequities
- Address the need for affirmative efforts to increase racial diversity and inclusion in the community, if current community residential and/or workforce demographics do not reflect a variety of races and ethnic backgrounds relative to the region



2021 Process criteria evaluation

- Criteria assume a dichotomy among cities all cities can engage and design projects with input from underrepresented groups
- Criteria intentionally focused on racial equity, but it wasn't clear that other types of equity could also achieve some points
- The first criteria was more differentiating than the second criteria
- Responses reflected less understanding of what the second criteria was looking for

DRAFT proposed 2022 criterion

The City is taking steps toward addressing racial and other inequities at the local level, especially efforts to implement equitable development practices

The City is taking steps toward addressing racial and other inequities at the local level, especially efforts to implement equitable development practices	5	2

Process criteria: minimum equity score

Criteria	2021 Points	Proposed 2022 Points
Project Outcomes - Equity Points - Step One	6	9
Project Process – Equity Points – Step One	10	7
TOTAL	16	16
