

### Key Scoring Changes Summary: LCDA and LCDA-TOD

- Project Process criteria is being clarified to better consider variation and context across LCA participating cities
- An equity-specific environmental and livability criterion has been added
- How equity criteria are scored has been clarified
- Affordable housing preservation is more clearly prioritized
- Jobs scoring criteria is being expanded to think more broadly about economic stability and opportunity

### Key Changes Summary: LHIA


- An affordable homeownership pilot would be administered directly by Council staff, rather than through Minnesota Housing's Consolidated Request for Proposals



- SEED eligible areas are expanding to more broadly address geographic equity
