Proposed Action

Information Item only. Feedback from the Committee will inform final recommendations for program scoring criteria.

Background

The Livable Communities Act (LCA) requires that the Council prepare an annual plan for distribution of the Livable Communities funds that includes scoring criteria for all LCA programs. Building upon the <u>November 15, 2021 information item</u>, staff is continuing conversations with the Community Development Committee before recommending adoption of criteria for 2022 LCA programs at the February 7, 2022, regularly scheduled committee meeting.

In 2021, the Council substantially changed LCA scoring criteria for the Livable Communities Demonstration Acount (LCDA) and LCDA-Transit Oriented Development (LCDA-TOD) programs to better reflect the foundational purpose of the Livable Communities Act and to improve clarity and transparency of the criteria. All programs reorganized the scoring criteria within three categories: Project Outcomes ("What"), Project Process ("How"), and Project Team ("Who").

For 2022 scoring criteria, staff are proposing changes that generally refine and improve the 2021 criteria, based on conversations with applicants, scorers, and our own observations on the scoring process over 2021. The majority of these changes simplify or clarify language, make small additions or omissions, or move the criterion to a different section where they would be more suitably scored.

In the attached appendices staff have provided a redlined and clean version of the proposed changes for the Tax Base Revitalization Account (TBRA), Livable Communities Demonstration Account (LCDA) and LCDA – Transit Oriented Development (TOD) Development programs, and the newly combined LCDA/TOD Pre-development program. Scoring criteria for the <u>LCDA/TOD Predevelopment Policy Expansion</u> and the <u>Local Housing Incentives Account (LHIA) Affordable Homeownership Pilot</u> were discussed at the December 6, 2021 Community Development Committee, and are not included in this information item.

Summary of substantial changes

Less substantive changes are explained in the Attachment 1, with a clean version provided as Attachment 2. More substantive or summary changes are described below.



Tax Base Revitalization Account (TBRA)

Overall alignment with all LCA programs

While LCDA and LCDA-TOD scoring criteria were substantially updated in 2021, TBRA scoring criteria, given its uniquely specific purpose and subject area, generally stayed the same other than reorganizing them into the three primary scoring categories of Project Outcomes, Project Process, and Project Team.

For 2022, staff have looked at where the intent of the TBRA criteria is substantively the same as LCDA and LCDA-TOD criteria in the Project Outcomes section (which generally occurs in the housing and jobs subcategories) and is proposing to update TBRA criteria to match the language in the LCDA and LCDA-TOD criteria more precisely.

Further, staff have identified where a few criteria specific to TBRA were placed in the primary category reorganization and recommend some changes to better match the criterion to the category.

Finally, staff are proposing changes to Project Process criteria and Project Team criteria to more closely match LCDA and LCDA-TOD when applicable. All of the changes described above can be seen in Attachment A. These recommendations, again, are primarily to create as much consistency and clarity in the criteria across the entire suite of LCA programs, rather than to make major changes to how TBRA applications are scored.

<u>Livable Communities Demonstration Account (LCDA) and LCDA – Transit Oriented Development (LCDA – TOD)</u>

Equity scoring

Committee members and Council staff have had discussion about how to score for equity given the myriad populations that experience inequities and disparate outcomes in our region. In 2021 staff specifically called out racial equity as the focus of some criteria yet also offered points for projects addressing other forms of equity. To be as clear as possible in our scoring approach, staff is proposing the following preamble at the beginning of the LCDA and LCDA-TOD scoring tables. Criteria would then only use the word equity, but the context from the following proposed preamble would apply:

LCA is focused on addressing racial inequity in the region given race is the largest predictor of inequitable outcomes in jobs, housing, and other LCA goals. Therefore, projects addressing racial equity will be prioritized in scoring. Projects addressing other inequities will earn points towards how they address those inequities but will not receive full points unless they also consider the intersection of racial inequity.

In 2021, the Council adopted criteria that required a minimum score of ten (10) from sixteen (16) available equity specific points in the Step One process of the LCDA and LCDA-TOD programs. Six (6) of these points came from three of the criteria in the Project Outcomes category and ten (10) of them came from the two criteria in the Project Process category. Staff discussion with the Community Development Committee on *November 15, 2021* proposed changes to the Project Process criteria that clarified how equitable project development and community engagement would be scored, and initially proposed reducing the total points available in the Project Process category from ten (10) to seven (7). Staff is currently recommending eight (8) points for the Project Process category as the preferred balance between equity points in Project Process compared to equity points in Project Outcomes. The two (2) points lost from the Project Process category would be allocated to a new environmental equity criterion in the Project Outcomes category. Finally, a Project Team equity criterion that was a part of

Step Two scoring in 2021 is being moved to Step One based on feedback from the Livable Communities Advisory Committee.

These changes mean the total points available from equity-specific criteria in Step One would increase to 18 (eighteen) and the minimum points required to move from Step One to Step Two would increase from ten (10) to twelve (12). The proposed changes are reflected in the tables below.

Scoring for preservation

In 2021 costs associated with rehabilitating and reserving buildings that provide jobs and/or affordable housing became eligible uses of LCDA and TOD funds for the first time. As hoped, applications for preservation projects were submitted in 2021 and were generally well received. Staff did note a few criteria that may inadvertently prioritize new construction over preservation, particularly in the compact, connected development and environment subcategories. Staff is proposing the following changes to improve preservation projects' ability to compete for funds (changes underlined).

Scoring for jobs

The direction from the Livable Communities Act relating to jobs focuses on "helping to change long-term market incentives that adversely impact creation and preservation of living-wage jobs in the fully developed area" (Minn. Stat. § 473.25, subd. a (1). The primary way scoring criteria have supported this direction is by awarding points for projects that directly create or preserve living wage jobs.

As a part of future evaluation work, LCA staff would like to better explore how the programs can more specifically support broader market impact, per the statutory language, as well as support *Thrive MSP 2040* outcomes of Livability, Prosperity, and Equity by considering what kinds of jobs our programs prioritize and what other efforts can incentivize those jobs.

While that evaluation work will take some time, for 2022 staff is suggesting changes to jobs scoring criteria that begins the process of broadening our understanding of economic stability and opportunity

across the region. Staff is proposing additions and changes to expand jobs criteria for 2022, as show in Table 4 below.

Project Team scoring

Two substantive changes are proposed for the final LCDA/TOD scoring category: Project Team. The first change moves a criterion awarding points to project teams that reflect and respond to the community the project is intending to serve. This was a Step Two criterion in 2021, but in partnership with the Livable Communities Advisory Committee (LCAC) members, who do Step Two scoring, staff determined this criteria more appropriately lives in Step One.

LCAC members also shared that it was difficult to not consider the funding sources for the proposals and the degree to which they impacted the proposal's ability to achieve the outcomes being presented. In 2021, the scoring criteria no longer considered funding commitments as research showed there was little correlation between the strength of funding commitments and the completion of the project, and rewarding fully resourced projects favored more capitalized, experienced developers. Instead, scoring in 2021 prioritized local efforts to contribute to the project financially.

To address both points staff is proposing a more nuanced criterion in step two that considers the role funding sources can play in achieving outcomes, but not the level of commitment the project has from listed funding sources. The specific criterion is proposed as follows:

 The funding sources identified, not necessarily committed, for the project reasonably reflect what is necessary to complete the project

Finally, staff is proposing a revised criterion in the Project Teams section to more clearly reflect its overall intention. The criterion that the project team can use the grant within the 36 month grant term is not currently effective at differentiating between proposals. All proposals assert the ability to do this, and it is a baseline expectation of all grant awards in LCA programs. Staff instead recommend replacing this with a criterion that pulls out something specifically valued in the LCA statutory language:

partnerships between government, private for-profit, and nonprofit sectors. Scoring based on the strength and type of partnership is a more accurate predictor of project success than a project team stating that they can use the grant in the time allotted.

This is a redlined version of the proposed 2022 criteria. Text shown in brackets briefly describes the rationale for the proposed change.

Tax Base Revitalization Account (TBRA)

The TBRA helps clean up contaminated land and buildings for subsequent development. These grants are intended to provide the greatest public benefit for the money spent, strengthen the local tax base, and create and preserve jobs and/or affordable housing. The TBRA is funded by a property tax levy established in statue that may not exceed \$5,000,000 annually.

Local Housing Incentives Account (LHIA)

The LHIA helps expand and preserve lifecycle and affordable housing, both rented and owned. The LHIA annual base funding includes \$500,000 transferred from the LCDA tax levy plus \$1 million from the Council's general fund.

LHIA Threshold Criteria

- A significant component of the project must serve households with incomes at or below 60% of Area Median Income (AMI) with a minimum affordability term of 15 years, for rental projects.
- Grantees must have an adopted Fair Housing Policy in order to receive Livable Communities
 Act funding.
- Projects must have affirmative fair housing marketing plans.

LHIA Competitive Criteria

- Rental proposals creating or preserving affordability for persons at or below 30% of AMI;
- New affordable housing that furthers the City's ability to meet their share of the region's need for affordable housing, considering what the need is across affordability bands

OR

Preserved/rehabilitated affordable housing, prioritizing communities at highest risk of losing Naturally Occurring Affordable Housing (NOAH) and/or communities with higher rates of housing cost burdened households.

- Proposals that serve large families by providing three or more-bedroom units;
- Proposals meeting the needs of individuals and households experiencing longterm homelessness;
- Proposals that provide a housing type not currently available or serve a population not currently served in or near the project area.

<u>Livable Communities Demonstration Account (LCDA) and Transit Oriented</u> <u>Development (TOD) Predevelopment</u>

The LCDA supports development and redevelopment projects that link housing, jobs and services and use community and regional infrastructure efficiently. TOD is focused on high-density projects that contribute to a mix of uses in the TOD-eligible area. TOD-eligible areas can be along light rail, commuter rail, bus rapid transit, and high frequency bus corridors. The LCDA is funded by a property tax levy that is distributed among the regular LCDA, the LCDA-TOD, and the LHIA.

LCDA and TOD Pre-Development

LCDA and TOD's Pre-development program is scored by Council staff using the following criteria.

LCA is focused on addressing racial inequity in the region given race is the largest predictor of inequitable outcomes in jobs, housing, and other LCA goals. Project addressing racial equity will be prioritized in scoring. Projects addressing other inequities will earn points towards how they address those inequities but will not receive full points unless they also consider the intersection of racial inequity.

What: Proposed Pre-Development Activity Outcomes

The pre-development activities will further the project's ability to meet LCA and/or Thrive geals: [It is not possible to effectively score on the quality of potential work or the impact that work will have on the project. Scorers will focus on the expected outcomes of the proposed project in the "What" section rather than specific requested activities.]

Create or preserve affordable housing, including depth of affordability, housing types, or special populations served, through activities such as public engagement, market studies, etc.

Create or preserve permanent, living wage jobs, through activities such as workforce training compatibility, business incubation, cooperative ownership models, public engagement, etc.

Local Housing Incentives Account (LHIA)

The LHIA helps expand and preserve lifecycle and affordable housing, both rented and owned. The LHIA annual base funding includes \$500,000 transferred from the LCDA tax levy plus \$1 million from the Council's general fund.

LHIA Threshold Criteria

- A significant component of the project must serve households with incomes at or below 60% of Area Median Income (AMI) with a minimum affordability term of 15 years, for rental projects.
- Grantees must have an adopted Fair Housing Policy in order to receive Livable Communities
 Act funding.
- Projects must have affirmative fair housing marketing plans.

LHIA Competitive Criteria

- Rental proposals creating or preserving affordability for persons at or below 30% of AMI;
- New affordable housing that furthers the City's ability to meet their share of the region's need for affordable housing, considering what the need is across affordability bands

OR

Preserved/rehabilitated affordable housing, prioritizing communities at highest risk of losing Naturally Occurring Affordable Housing (NOAH) and/or communities with higher rates of housing cost burdened households.

- Proposals that serve large families by providing three or more-bedroom units;
- Proposals meeting the needs of individuals and households experiencing longterm homelessness;
- Proposals that provide a housing type not currently available or serve a population not currently served in or near the project area.

<u>Livable Communities Demonstration Account (LCDA) and Transit Oriented Development (TOD) Predevelopment</u>

The LCDA supports development and redevelopment projects that link housing, jobs and services and use community and regional infrastructure efficiently. TOD is focused on high-density projects that contribute to a mix of uses in the TOD-eligible area. TOD-eligible areas can be along light rail, commuter rail, bus rapid transit, and high frequency bus corridors. The LCDA is funded by a property tax levy that is distributed among the regular LCDA, the LCDA-TOD, and the LHIA.

LCDA and TOD Pre-Development

LCDA and TOD's Pre-development program is scored by Council staff using the following criteria.
