




# **PBV Summary**

- •6,894 Vouchers
- HUD allows up to 20% PBV
- •970 PBV units awarded (14%)
- 55 Developments
- 33 Communities


# **Current Voucher Split**

# **Project Based Voucher Policy**



## **Metro HRA will:**

- Operate a PBV program using *up to* 20 percent of vouchers
- Offer and award PBVs in the following  ${\color{black}\bullet}$ ways:
  - Independent Request for Proposals (RFP) process
  - Offer through Minnesota Housing RFP process
- Prioritize PBVs in its own operating area

# 2022 PBV Offer

### Metro HRA offered up to 20 Veteran's Affairs Supportive Housing **Project Based Vouchers – VASH PBV**

- VASH
  - Serves veterans experiencing homelessness
  - Department of Veterans Affairs provide referral and services
  - Metro HRA provides rent subsidy
- RFP Issued March 15, 2022
- Applications Due April 15, 2022 ۲
- Received two applications for a total of 9 VASH PBVs
- RFP requires projects to receive full funding in 2022 to receive formal PBV award •



# **Two Applications Received**

## Carver Oaks Senior Residences – Carver, MN

- New construction, 43-unit senior affordable housing
- One and two-bedroom units
- Requested 7 VASH PBVs
- Met initial eligibility criteria
- Received a Letter of Intent to commit the PBVs
  - Full funding in 2022 = project will receive formal PBV approval
  - Not full funding in 2022 = project will need to reapply for PBVs at a later date

# **Two Applications Received**

## Nolte River Place Apartments – Anoka, MN

- New construction, 80-unit senior affordable housing
- One and two-bedroom units
- Requested 2 VASH PBVs
- Did not meet initial eligibility criteria
  - Not eligible as new construction already broke ground
  - Not eligible as existing housing project not complete
- Project will need to reapply for PBVs at a later date
