Funding Availability




2023 Fund Distribution Plan

As part of the Fund Distribution Plan, the Council approved up to \$2,000,000 for LCA Pre-Development grants to be awarded in two application rounds with \$1,000,000 available in each funding opportunity.

The Policy Development grants are funded from the same Pre-Development funding source.



Chaska Zoning Code Update

City of Chaska

Recommended Award: \$50,000

- Reduce parking requirements and rightsize landscaping for multi-family projects
- Support more multifamily, affordable housing in the city



Fridley Zoning Code Update

City of Fridley

Recommended Award: \$15,000

- Reduce off-street parking requirements and develop incentives for active transportation options
- Landscaping standards to support resilient environments




New Brighton ADU Policy
