## **Background**

The Council continues its work on developing the 2050 Regional Development Guide, *Imagine 2050*. The current Regional Development Guide, *Thrive MSP 2040*, along with the Council's system and policy plans, help guide the orderly growth and development of the Twin Cities metropolitan region. The four policy plans include the *2040 Regional Parks Policy Plan*, the *2040 Transportation Policy Plan*, the *2040 Water Resources Policy Plan*, and the *2040 Housing Policy Plan*.

At the May 6, 2024, Community Development Committee (CDC) meeting, Council Parks staff will facilitate a high-level conversation about the proposed changes to the Regional Parks and Trails Policy chapter of the 2050 Regional Development Guide. These changes are captured in Attachment 1, the Summary of Changes section of this report. Parks staff will provide a high-level overview of the draft 60% chapter (formerly the 2040 Regional Parks Policy Plan and Attachment 2). Staff will direct Council Members to certain areas of the plan that they are especially interested in gathering committee member feedback.

On May 2, 2024, prior to the CDC meeting, Parks staff will present the 60% draft to the Metropolitan Parks and Open Space Commission. Staff will share high-level learnings from MPOSC with Committee Members verbally during the meeting.

The draft 60% Regional Parks and Trails chapter is the result of numerous discussions with Regional Park Implementing Agencies, the Metropolitan Council's Committee of the Whole, Community Development Committee, and the Metropolitan Parks and Open Space Commission, as well as extensive outreach to prioritized communities.

Additionally, Council staff are carefully reviewing the existing Regional Parks Policy Plan content to ensure it is fundamentally oriented to objectives, policies, and actions. Content that is contextual, procedural, or includes more detailed requirements, is proposed to be moved into a Regional Parks and Trails Planning Handbook. Staff will share emerging thinking about this proposal with MPOSC at the upcoming June meeting (Table 1).

Moving beyond the 60% Draft, Council staff will continue to revise and refine regional parks and trails objectives, policies, and actions, as well as the proposed Regional Parks and Trails Planning Handbook, as a result of this and future discussions with Regional Park Implementing Agencies, Council committees, and others.

The May 2, 2024, MPOSC meeting continued a series of focused discussions on the Regional Parks Policy Plan that began last spring. Council staff shared the proposed changes to the Regional Parks and Trails Policy chapter (Attachment 1), a high-level overview of the draft 60% Regional Parks and Trails chapter (formerly the 2040 Regional Parks Policy Plan) (Attachment 2), and a deeper look into the Recreation, Facilities, and Programming, and Finance sections of the chapter.

At the most recent MPOSC meeting, on April 2, 2024, Council staff shared feedback from Regional Park Implementing Agencies, MPOSC, and the Committee of the Whole. These discussions have resulted in key takeaways that helped Council staff further refine and shape the draft policies and actions.

At the March 2023 MPOSC meeting, staff shared Council-endorsed values and vision statements for the Regional Development Guide. Staff also shared a summary of the Regional Parks Policy Plan update work to-date, including a project timeline and a plan for working directly with Regional Park Implementing Agencies via a series of workgroups.

At the April 2023 MPOSC meeting, Council staff led small group activities focused on developing vision, mission, and value statements for the regional parks and trails system. An Implementing Agency-Council workgroup continued this work.

In June 2023, Council staff sought MPOSC's advice on developing shared regional goals and policy area objectives. Policy area objectives connect regional goals to policies and actions.

In August 2023, Council staff sought MPOSC's feedback and advice on community engagement activities, and regional parks and trails system vision, mission, and values. Staff also shared updates on regional goals and the launch of two additional parks policy plan workgroups.

In November 2023, Council staff shared outcomes of the most recent Agency-Council workgroups and draft regional parks and trails objectives. MPOSC provided feedback and advice on draft parks objectives.

At the January 4, 2024, meeting, Council staff shared a proposal for engaging MPOSC for the first five months of 2024 and sought advice on a revised set of draft parks objectives.

At the February 1, 2024, meeting, Council staff shared a revised set of draft parks objectives based on the input of MPOSC and Regional Park Implementing Agencies. Again, MPOSC provided advice on priorities to achieve draft parks objectives.

Minnesota law requires the Council to conduct a comprehensive review of the Regional Parks Policy Plan at least every four years (Minnesota Statutes, section 473.147). The policy plan was last updated in December 2020. Completion of the policy plan update, as an integrated part of *Imagine 2050*, is expected in late 2024 or early 2025.
