Ongoing Conversations on Recommended Density Approaches

Density Policy Decisions

- Increase minimum density requirements.
- Restrain MUSA expansion and establish criteria for when expansion would be authorized.
- Establish a minimum density requirement for all new connections to the regional sewer system.*
- Evaluate the feasibility of demand and development of land uses based on practicality.

Administrative Practices and Guidelines

- Consider all land guided to support growth, not just areas of change
- Calculate density requirements per decade rather than over the planning horizon
- Use a performance-based approach to explore flexibility in minimum planning requirements while advancing regional goals.


Up Next for Land Use and Density Policy



Moving toward the public comment draft


- CDC and LUAC will continue discussions:
 - Density Analysis Report and Recommendations
 - TOD Analysis and Recommendations
 - Methodology to evaluate practical feasibility of demand and development
 - Criteria for MUSA Expansion
 - Criteria for performance-based flexibility and program needs (enrollment, eligibility, tracking)
- Balance revisions; weigh feedback of underrepresented communities to ensure voices are heard equitably.

Why versions 1, 2, 3...?



We want to get this right

Preliminary Local Forecasts (version 1) does not yet reflect known/ proposed developments; transportation model results; nor any new regional policies.

Local governments commented, Jan. 25 – Feb. 29

Proposed Local Forecasts (version 2) will update regional system characteristics, including a refresh of planned transportation and transit networks.

Expected Summer 2024. Public hearing, Aug. 15 – Oct. 7, 2024

Improvements expected for proposed local forecasts (version 2)



Process programming adjustments

- Improvement of housing product mix prediction
- Improvement of population per household prediction

Data inputs

- Reflect known developments, in the right places, thru 2023
- Update predictor data: land values, local planned land use capacities
- Update system characteristics: 2050 MUSA, high frequency transit geography, future accessibility skims

Post-model limits and rules

Constrain growth, to less than what could be modeled, where such growth would contravene policies

Aug. 15 – Oct. 7, 2024	 Review and comment on Proposed Local Forecasts v. 2 Includes population, households, employment for counties, cities, townships, subcity sewer-serviced, and Transportation Analysis Zones Part of public comment period for <i>Imagine 2050</i>
Sept. – Dec. 2025	 Review and comment on System Statement Local Forecasts Includes population, households, employment for counties, cities, townships, subcity sewer-serviced and policy areas Part of appeals period for System Statements
2026 – 2028	 Preparation and review of Comprehensive Plan Updates Met Council and local governments can agree to local forecast revisions as expectations and plans evolve
2026 – 2034	 Preparation and review of Plan Amendments Met Council and local governments can agree to local forecast revisions as expectations and plans evolve

Proximity & Choice

Fair Housing & Geographic Choice

People regardless of ability, age, financial status, race, and family size, can live in a community they choose

Options to Own or Rent

Rental and ownership options are available to all households regardless of income

Dignity & Safety

Quality

Affordable housing is built to a high standard and maintained, safe, and accessible for all residents

Stability

Stable, affordable, and dignified places to live are available to everyone, especially those experiencing housing insecurity and homelessness

Connection & Wellbeing

Cultural Connection & Wellbeing

Everyone has access to homes, not just housing

Equity

Repair historic and ongoing injustice in housing practices and outcomes

Environmental Justice

Housing in our region is resilient to climate change impacts and furthers environmental justice

Recent Engagements: What are we hearing?



Metropolitan Parks and Open Space Commission

- Overall support for plan development and direction.
- Recommend greater consistency in terminology and demographic references.
- Support for new Cultural Landscapes and Historical Landscapes subclassifications.
- Support for Council-led Climate Resiliency & Natural Systems work.
 - Continue developing meaningful metrics.
 - Make connections to public transportation and other Council systems.

Recent Engagements: What are we hearing?



Implementing Agency Partners

- Provided practical, detailed feedback on both Policy Plan and Planning Handbook, which is informing Public Comment Draft.
- Support for Cultural Landscapes and Historical Landscapes subclassifications.
- Support for "cultural resources inventory" as part of long-range planning requirements, but additional dialogue needed first.
 - o Include in workplan

Regional Parks and Trails Policy Changes: What's New?



Significant Changes to Parks and Trails Policy

- Modifies "Special Recreation Feature" classification to "Special Feature" and creates two new subclassifications: Cultural Landscapes and Historical Landscapes (Workplan Item). Does not require recreation be part of the unit.
- Advances equity by acknowledging our shared history and reinforces its importance in the regional parks and trails system.
- Elevates and strengthens the importance of natural systems and climate resilience work.
- Strengthens the Council's commitment to regional trail system and Regional Bicycle Transportation Network coordination.

Regional Parks and Trails Policy Changes: What's New?



Significant Changes to Parks and Trails Policy

- Recommends and reinforces Council's commitment to fund and administer the Equity Grant Program for projects explicitly aimed at strengthening equitable use.
- Increases program cap for Park Acquisition
 Opportunity Fund Program to \$2M for Parks and Trails
 Legacy Fund and \$3M for Environment and Natural
 Resources Trust Fund.
- Establishes first-ever Parks and Trails Planning Handbook, a complementary, stand-alone document that contains procedural and contextual information such as handbook update procedures, system additions process and criteria, long-range plan requirements, and system protection processes
