

Equity Analysis

Focused Engagement:

- Prioritized future users and local community members.
- Engaged youth visitors through focus groups with Saint Paul Youth Commission and students of Metro Deaf School, Como High School, and Hmong College Prep Academy.
- Reached local groups through existing local events, including open houses.

Advice Shaped the Plan:

The top five priorities identified by stakeholders are:

- Improve safety and ADA accessibility at trail crossings.
- Plant and maintain trees for added shade and add more native plantings for habitat.
- Increase pedestrian lighting for safety; add site furnishings such as benches, bike parking, and drinking fountains.
- Consolidate trail system, resurface and widen paths, improve accessibility to lakeshore and other park features.
- Consider closure of East Como Lake Drive to improve water quality and bike/pedestrian safety.

Partner Engagement

- Convened a Technical Advisory Committee consisting of City staff from different departments to propose ideas.
- Collaboration with Capitol Region Watershed District (CRWD) to improve the water quality of Como Lake. **Partner Engagement Themes**
- Improve and update wayfinding
- Explore adding amenities like a possible dog park or more restrooms throughout the park
- Potential location for CRWD stormwater project
- Improved trail connectivity within and adjacent to the park
- Exploring the idea of closing East Como Lake Drive and the potential benefits and drawbacks

- Hosting an online engagement tool and surveys.


Public Engagement Themes

- Consider the closure of East Como Lake Drive
- Better understand indigenous history and significance of land at Como Regional Park and work with local groups

- High Priority (implemented within 10 years):
 - Increase trail safety through improved ADA accessibility and adding lighting where appropriate
 - Plant trees and native plantings for shade and habitat restoration •
 - Incorporate stormwater best management practices to trail \bullet infrastructure

Medium Priority (10-15 years):

- Consolidate trail systems, improve circulation to the lake, and ulletwiden high traffic areas
- Update lakeside pavilion to make it more visitor friendly, provide • access to the lake, and improve circulation (further study needed)
- Increase seasonal programming opportunities •

Low Priority (15-20 years):

- Consider closure of East Como Lake Drive (further study needed)
- Implement two-way bike traffic along the Grand Round route and • around Como Lake
- Improve wayfinding and signage across the park
- Explore alternative recreational activities (disc golf, skills park, dog park)

Natural Resources



Como Lake

- Como Lake is listed on the Priority Waters List, which provides significant recreational and tourism value to the region.
- Historically has poor water quality due to high • phosphorus runoff and algal blooms.
- CRWD and Saint Paul are working together to improve ulletwater quality through restoring shorelines, continued monitoring, and stormwater best management practices.
- Proposal to install new sand filter and bioretention • basin in the northwestern Golf Course pond to remove phosphorus before leaving the area.

Plan implementation and improvements:

The cost is anticipated to be \$57.9 million on the low end and \$96.4 million on the high end, with an anticipated annual project cost of approximately \$65,000.

Acquisitions: \$421,603

Operations & maintenance annual cost: \$1.450 million annually

Proposed Action



That the Metropolitan Council:

- Approve the Como Regional Park Long-Range Plan.
- Advise the City of Saint Paul to consider 2. implementing the recommendations for solar resources and population forecasts in the Advisory Comments section of the business item.
- Require the City of Saint Paul, prior to initiating 3. any new development of the regional park, to send preliminary plans to the Metropolitan **Council's Environmental Services Interceptor** Engineering Assistant Manager.
