

Imagine 2050 Public Comment Period



- Public comments for Imagine 2050 (all policy areas) were accepted from August 15 to
 October 7.
- Overall received more than 1,200 comments from approximately 500 organizations and individuals.
 - 270 comments on Imagine 2050 Vision, Values, Goals
 - Topics include (positive, neutral, negative):
 - Goal areas: mostly on equity, climate, and natural systems
 - Overall engagement and collaboration
 - Length and organization of the document

Themes



Vision, Values, Goals

- Generally supportive of the regional vision, values, and goals comments on whether vision, values, and goals resonated with them and their lived experiences.
- Residents wanted to make sure that the needs of disabled people, elders, and youth were served by 2050 policies.
- Overwhelming support for climate change mitigation from the Council.
- Residents want the region to be accessible to people with disabilities and in compliance with ADA requirements.
- Some thought the range of areas covered by the document was too broad or did not see the connection to the Council's work
- Suggestion to celebrate the successes of the region and the things that make this region great
- Appreciation for the planning process, collaboration with Council staff during the planning process
- Comments regarding implementation: important partners, needs for funding, and topics for technical assistance

Overall Goals, Vision, Values

"We are encouraged to see the draft Imagine 2050 clearly emphasizes the crossfunctional work of natural systems, public health, safety, climate change, equity, and well-being. The Metropolitan Council's values are aligned with the County's recently adopted core values of caring, collaborative, equitable, ethical, fiscally responsible, responsive, and sustainable." (Government)

"We appreciate the four core values of stewardship, accountability, leadership, and equity. One area to highlight further within these values is partnerships and the collaboration needed to achieve the goals of the plan. Partnerships with other agencies, utilities, community members, etc. " (Organization)

"That they hinge upon each other to be successfully implemented. For example: yes, we must protect and restore natural systems and yes, we must ensure our region is equitable and inclusive. Efforts made to accomplish each goal also need to address other goals. We need to consider the equity and inclusiveness of which natural systems we protect and restore." (Resident)

"In general, the statements made in the Vision, Values, and Goals Chapter does not meaningfully reflect the actual vibrant region that we are very fortunate to live in. Our region thrives with quality transportation, robust recreation and a strong economic base. Those qualities should be the foundation of this plan and for the future growth and development of the region." (Government)

Engagement & Collaboration

Overall Revisions Proposed



Across all areas

- Housekeeping corrections e.g. typos, grammar, punctuation, footnotes
- Review of goal areas for opportunities to provide structural consistency among the goals
- Updates to charts and figures
 - Some data updates
 - Visual consistency
- Other minor changes responding to specific comments, clarifications, or corrections



Landscape of the Region

- Add the full Land Acknowledgement language
- Add introductory language expanding upon the successes and great things about the Twin Cities Region, including language exemplifying the success of regional collaboration
- Expand upon widespread impacts of COVID-19 across all populations
- Update the local forecasts section dependent on changes to local forecasts and community designations
- Add discussion on planning for the aging population and for people living with disabilities



Intro & Regional Vision, Values, Goals sections

- Include language around the intersectional nature of the goals
- Expand upon how the goals are interwoven through the policy chapters
- Include explanation about the relationship between these goals and how they guide the Council's work as well as provide direction or encouragement to others in the region



Our Region is Equitable and Inclusive

- More clearly connect inequities of the past to present-day practices
- Add an example of the application of the Community-Centered Engagement Framework
- Update the Land, Water, and People
 Acknowledgment and Council Commitments
 to Act section based on recommendations
 from the American Indian Advisory Council



We Lead on Addressing Climate Change

- Streamline the current emissions reporting section
- Update language depending on the allocation of Transportation emissions from MnDOT

We Protect and Restore Natural Systems

Add language regarding state shoreland rules and other existing water protective state-level rules that we may have missed

Next Steps



- December January:
 - Prepare public comment report
 - Finalize proposed revisions to the plan
- January 21, 2025: Community Development Committee: Draft final Regional Development Guide and public comment report (business item)
- February 12, 2025: Metropolitan Council adoption of Imagine 2050





Who knows and understands the parks, forest, or greenery better than those who originally birthed it, cared for it, and nurtured itour ndigenous neighbors.	Thank you for sharing your belief that all residents of the region should feel comfortable and welcome at regional parks and trails across the system and voicing support for hiring staff that are reflective of the demographic makeup of the region. Metropolitan Council staff will share the advice about the importance of hiring staff to better reflect the region's residents with regional park implementing agencies.
