Dakota Land, Water, and People Acknowledgment

The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

 - 1. Approve a grant of up to \$2,910,158 from the Park Acquisition Opportunity Fund to the Minneapolis Park and Recreation Board to acquire the West Park and East Park parcels totaling 1.4 acres located at 525 Malcolm Avenue South in Minneapolis, MN, for the Grand Rounds Missing Link Regional Trail.

2. Authorize the Executive Director of Community Development to execute the grant agreement and restrictive covenant on behalf of the Council.

In one instance, funding was reduced to match eligible costs confirmed during the evaluation. The Committee also asked where additional details can be found about individual projects, the use of the unawarded funding balance, and the typical number of awards in recent grant cycles.

Information

1. 2025 Housing Choice Voucher Waitlist Opening Updates (Caitlin Magistad 651-602-1212; Ryane Ottengheime Leifheit 651-602-1869)

The Metropolitan Council Housing and Redevelopment Authority (Metro HRA) opened its Housing Choice Voucher (HCV) waiting list from Wednesday, April 9th through Wednesday, April 16th, 2025. The HCV program provides rental assistance to households with very-low incomes.

During the week-long opening, the Metro HRA received 11,172 applications. 1000 families were randomly selected for placement onto the HCV waiting list. Council staff plan to provide updates on the 2025 HCV waitlist opening including:

- 2. 2050 Regional Parks and Trails Policy Plan Amendment: Modernizing Mapping (Tracey Kinney 651-602-1029; Kevin Phan 651-602-1333)

The Modernizing Regional Parks and Trails Mapping project proposes to amend Section 2, System Plan, of the 2050 Regional Parks and Trails Policy Plan, to establish the:

Regional Parks and Trails System Geographic Information System (GIS) dataset as the Met Council's primary reference on file and Make the Section 2 System Plan boundaries consistent with the GIS dataset.

While no policy changes are being proposed as part of this Policy Plan amendment, this proposed action seeks to formalize the Met Council's use of the GIS dataset to support approved regional park and trail long-range plans, as well as reconcile long-range plan and data inconsistencies.

Regional park and trail boundaries are tracked through a mapping system comprised of approved long-range plans, proposed GIS data, and legal land records. Regional park and trail long-range plans are high-level documents that define a regional unit's boundaries, acquisition, development, and operation of regional facilities. Park and trail long-range plans will continue to serve as the vehicle for Council approvals. The GIS data will work in concert with the approved long-range plans providing a higher-level of detail for use with planning questions and acreage calculations. The GIS data is updated annually in partnership with the ten regional park implementing agencies as part of the Operations and Maintenance Program fund distribution process. The legal land records will continue to serve as the basis for land exchanges, acquisitions, and boundary adjustments.

The Regional Parks and Trails System has grown substantially since its inception in 1974,

making it necessary to embrace technological advancements and policy plan process improvements.
