## **Proposed Action**

That the Metropolitan Council ratify the attached *Justification for and Declaration of Emergency* for repair of the Burnsville Lift Station L-13 Forcemain.

## **Background**

A small leak has developed in the forcemain adjacent to the Burnsville lift station L-13 which requires immediate repair. This portion of the forcemain has experienced significant settlement and a fitting adjacent to the meter structure has begun to leak. A length of pipe and fittings must be replaced to account for this and any future ssettlement. Nicols Road will be disturbed during the repair and will require restoration.

#### Rationale

Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and placed on a following Council consent list for formal ratification.

"A declared public emergency is an emergency situation in which the health, safety or welfare of the public or the safety of Metropolitan Council employees or facilities is compromised or potentially compromised and requires immediate action to correct."

Describe the nature of the emergency situation:	A raw wastewater leak was reported February 23, 2013 adjacent to the meter vault outside the Burnsville lift station L-13.
Explain why this situation is a present, immediate, and existing emergency:	A small amount of wastewater, approximately 5 - 10 gpm was observed flowing into the adjacent ditch.
Explain how this emergency does or will affect the healthy, safety, or welfare of the public or the safety of Metropolitan Council employees or facilities:	A break in a wasewater pipe needs to be immediately addressed.
Describe the supplies or services which must be acquired to remedy this emergency situation, including the estimated cost:	Excavation to find the source of the leak and repair the damaged pipe.
	Estimated cost: \$150,000
Identify how you chose the contractor(s) (Emergency Contractors List, vendor database, etc.):	The contractor which was selected has the required equipment mobilized within 2 miles of the leak location and was able to respond immediately. This contractor is very experienced and has performed this type of repair for the Council previously.

Based on the above information, an emergency situation exists within the meaning of the Council Procurement Policy. Carrying out the competitive bidding process and the technical requirements of the Council's Procurement Policy, and awaiting Council declaration of an emergency and approval for the purchase of materials or supplies or the making of emergency repairs would significantly and unacceptably delay the commencement of repair work on the above-referenced project.
