Proposed Action

That the Metropolitan Council Ratifies the attached justification for and declaration of emergency for effluent pump repair at the Metro plant.

Background

Two of the six effluent pumps that discharge the effluent from the plant during high river levels had high vibration levels during the last flood event. Both need to be removed, refurbished and reinstalled before the spring flooding season in 2015. Quotes were obtained, but exceeded \$160,000 per pump. This level of expenditure normally requires going through the formal bidding process.

Due to the lead time of the pump repairs combined with the time required for the formal bidding process, it would not be possible to have the pumps back in service before a spring flood event using standard procedures. This would put the Metro plant at risk of not being able to keep up with influent flows during a high water / high rain event.

Rationale

Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and placed on a following Council consent list for formal ratification.

"A declared public emergency is an emergency situation in which the health, safety or welfare of the public or the safety of Metropolitan Council employees or facilities is compromised or potentially compromised and requires immediate action to correct."

Describe the nature of the emergency situation:	Two of the six Effluent Pumps had high vibrations during the 2014 flood event and need to be sent out to be refurbished before the spring flooding of 2015.
Explain why this situation is a present, immediate, and existing emergency:	Due to the lead time of the pump repair combined with the time line for an Advertisement for Formal Information for Bid it would not be possible to have the pumps back in service before a spring flood event.
Explain how this emergency does or will affect the healthy, safety, or welfare of the public or the safety of Metropolitan Council employees or facilities:	These Effluent Pumps are required to pump the discharge flow from the Metro Plant during a high water event. There is no other way to get flow out of the plant and pump failure would result in a flooding of our process equipment and tunnels or a diversion to the river to control the influent flow.

Describe the supplies or services which must be acquired to remedy this emergency situation, including the estimated cost:	Qualified vendor to remove, ship, refurbish, install two pumps. Estimated cost: \$450,000

They were also the low bidder of the two quotes we received.
