




#### Location

#### **Cost Estimate**

Diversion System	\$851,000
Filtration and Disinfection	\$7,438,000
Storage and Pumping	\$5,287,000
Distribution Piping (County Road 71 Route)	\$14,121,000
Total	\$27,697,000

Project Cost: construction cost (with contingency), engineering and administrative costs, inflation, land acquisition and permitting
