2021-286 SW: Janitorial Services at the Metropolitan Wastewater Treatment Plant, Contract 21P196

Requests that Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 21P196 with FBG Service Corporation (FBG) to provide janitorial services for the Metropolitan Wastewater Treatment Plant in an amount not to exceed \$718,673. This is a same week request for approval due to the current contract extension terminating at the end of the month.

2021-287: Municipal Solid Waste and Industrial Waste for Metropolitan Council Environmental Services Facilities, Contract 20P289A

INFORMATION

1. Americans with Disabilities Act Transition Plan Update

Staff presented an update on efforts regarding the Americans with Disabilities Act (ADA) Self-Evaluations conducted from June 2019 to December 2019. The evaluation reviewed all Council facilities for compliance with the ADA design standards for physical accessibility which included parking lots, tour routes, building entrances, and bathrooms. The Council created an ADA Transition Plan to detail its efforts to address the findings.

Chair Lindstrom stated sounds like progress is being made.

Committee Member Sterner appreciates the work being done for citizens of the region. Staff stated work will continue on this project for some time to continue addressing needs.

2. General Manager Report

Agenda was packed with a great deal of work being done addressing our strategic goal areas of sustainable communities, sustainable services, and sustainable infrastructure. Information was shared about how we are working with our partners to conserve and utilize the region's groundwater and surface water in ways that protect public health and support economic growth and development. affordable wastewater infrastructure. It provides the best long term, regional value these projects are gong to be pretty exciting to see unfold. The Hastings plant has been discussed for some time and it will be good to move the project forward.
