Overview



- Minnesota Session Law 2023, Chapter 40, Article 2, Section 8(b)
 - \$750,000 the first year and \$750,000 the second year are for the water demand reduction grants to assist municipalities in the metropolitan area with implementing water demand reduction measures to ensure the reliability and protection of drinking water supplies.
- Goal: support technical and behavioral changes that improve municipal water use efficiency in the sevencounty metropolitan area

Total appropriation of \$1.5 million



Program plan for 2024-2026

- \$1,100,000 for existing grant program structure
 - Planning to solicit applications for the standard grant program in mid-February (2/15)
- \$400,000 to expand equity pilot projects
 - Convening conversations with communities to co-create program in 2024

Award and selection details



Awards

\$1,100,000 available July 1, 2024 through June 30, 2026

- Must be served by a municipal public water supply system
- Grant award range: \$5,000 \$50,000
- Requires matching amount: 20% municipality, 80% Council

Selection criteria note

Criteria used to inform the amount granted:

- Identified water supply issues in Master Water Supply Plan Community Profiles or Local Water Supply Plans
- Ratio of peak monthly water use to winter monthly water use •
- Average residential per capita water use
- Order of applications

- Irrigation controller replacement
- Irrigation spray sprinkler body replacement
- Irrigation system audit
- Clothes washing machine replacement
- Residential dishwasher replacement


