Recommendations Summary



Re-chartered EJ Task Force

- Create EJ Framework, building off Climate Action Work Plan-Environmental Justice Task Force's existing work
- In the framework, include EJ guidelines for project implementation. Understand that each project is nuanced, and create processes that allow projects to work from broad principles but address specific concerns (both Council-related and community-related concerns)
- Assess impacts of projects on overburdened communities
- Work with other equity-related groups in Council

Results: Spatial-Locational Impacts



- Some actions (~6) flagged as high likelihood of spatiallocational EJ impacts
- Some actions (~9) flagged as potential likelihood of spatiallocational EJ impacts
- NOTE: Spatial-locational impacts can be both positive and negative

- Need for collaboration Council should convene on climate for the region, fostering new and lasting partnerships
- EJ approach to climate welcomed Participants were interested that the Council is being more intentional on EJ
- Shared enthusiasm for climate work beyond mitigation Interest in intersectional issues related to climate and resilience
- Strong interest in Council's role in transportation and transit Participants are very engaged in Council efforts on transportation electrification and emissions reductions (through vehicle miles traveled and other means)
