#### Minnesota Statute 473.859

"...a housing element containing standards, plans and programs for providing adequate housing opportunities to meet existing and projected local and regional housing needs, including...the use of official controls and land use planning to promote the availability of land for the development of low and moderate income housing."



### Housing element structure

### Existing housing needs

- Existing housing assessment
- Identification of needs and priorities



### Projected affordable housing needs

- Allocation of affordable housing need
- Promoting the availability of land



### Implementation program

 Public programs, fiscal devices, and specific actions to meet existing and projected needs



# Existing housing assessment: Opportunities to communicate and collaborate

- Provide data and maps for the existing housing assessment
- Provide technical assistance to identify strategies to address existing housing needs
- Connect strategies to their impact on a community's Housing Performance Score



# Projected housing needs: Opportunities to communicate and collaborate

- Provide each community with their Allocation of Affordable Housing Need
- Provide technical assistance to identify opportunities to guide land at densities that support their Allocation of Affordable Housing Need
- Inform communities that their Allocation of Affordable Housing Need is a forecast for planning not a mandate for production



# Implementation program: Opportunities to communicate and collaborate

- Provide technical assistance to identify the <u>programs</u>, <u>fiscal devices and other specific actions</u> that can be used to meet <u>clearly identified</u> existing and projected housing needs
- Facilitate improved knowledge of state housing programs among local city staff
- Encourage participation in funding opportunities through the Livable Communities Act



### Need, Goals, and Scores

Council Role	Allocation of Affordable Housing Need	Affordable and Life- cycle Housing <i>Goals</i>	Housing Performance Scores
What	Forecasts the future need for affordable housing. Allows communities to plan for their share of the regional need.	Negotiated housing goals for housing production that communities agree to actively pursue and encourage.	Used in grant funding decisions to incent communities to create and maintain affordable housing
Why	Metropolitan Land Planning Act	Livable Communities Act	Council Policy
