SUBJECT: Revised 2017 Work Plan for Land Use Advisory Committee

This memo was prepared at the direction of the Chair of the Metropolitan Council's Land Use Advisory Committee, Council Member Jon Commers. It reflects revisions to the work plan discussed by the Committee on November 17, 2016, and February 16, 2017.

In 2017, LUAC members will contribute to efforts that focus on a new phase of implementation and planning. Local governments will be updating or preparing to update their local comprehensive plans due by the end of 2018. After the Council adopted *Thrive MSP 2040*, the Council is supporting the implementation of policies and strategies. Work is under way on updating the Transportation Policy Plan (TPP), due every four years to meet federal requirements.

Review of main accomplishments in 2016

 - Added on-demand program for communities to request informational workshops
 - Opened up marketing efforts so local officials attended or registered for events
- TOD Guide
 - o Gave feedback on approaches and features used to update the online TOD Guide
 - Provided input used to improve case study summaries
- Housing and affordable housing
 - Focused on the implementation of affordable housing
 - Suggested ways to effectively communicate
- Planning Assistance Fund
 - Served as primary committee for advice and input to develop program options
 - Recommended a preferred option to the Community Development Committee
- System Statements and potential system statement hearings
 - Prepared for statutory role in potential statement hearings
 - Helped staff make the hearing process clearer and more understandable to local officials and other staff
