Livable Communities Act Overview

- State legislation adopted in 1995
- Voluntary program for Cities to have access to for various types of (re)development grants
- To participate, cities must:
 - Adopt affordable and life-cycle housing goals
 - Create a Housing Action Plan that articulates how those goals will be met
 - Expend a minimum amount of local budget on affordable and life-cycle housing opportunities




Livable Communities Act Overview

- Overarching goals of program:
 - Compact, efficient development
 - A full range of housing choices throughout the region
 - Creation and preservation of living-wage jobs
- Programs guided by annual adoption of a Fund Distribution Plan, which sets:
 - Award amounts
 - Application deadlines
 - Scoring criteria



Tax Base Revitalization Account (TBRA)

- Funding for the cleanup of polluted land
- Spring and Fall grant rounds
- Three types of grants:





Livable Communities Demonstration Account (LCDA)

- Funding for the projects that efficiently link housing, jobs, transit and communities
- Spring and Fall grant rounds for pre-development
- Summer round for regular development

Pre-development

•\$500,000 per year

Development

•\$7M - \$9M per year



LCDA- Transit Oriented Development (LCDA-TOD)

- Funding for the projects that efficiently link housing, jobs, transit and communities
- Spring and Fall grant rounds for pre-development
- Summer round for regular development

Pre-development


•\$250,000, twice per year

Development

•\$4.5M per year



LCDA-TOD Eligible Areas



Corridors with LCA TOD Eligible Stations

- Blue Line / Blue Line Ext.
- Northstar Commuter Rail
- Green Line / Green Line Ext.
- ■ Red Line
- Orange Line
- Gold Line
- Rush Line*
- Riverview (Modern Streetcar)*
- Arterial BRT

LRT and BRT Stations

- Transit Station (Existing or Planned)
- Area Within 1/2 Mile of Station

High-Frequency Local Bus Routes

- Area Within 1/4 Mile of Route
 - Every 15 minutes (or better)
 - Weekdays 6 am to 7 pm, and Saturdays 9 am to 6 pm
- High-Frequency Local Bus Route

High-Frequency Express Bus Stations

- Area Within 1/2 Mile of Station
 - Significant Passenger Infrastructure Investments Are In Place
 - Buses Operate 6 Trips During AM Peak Hour (6-9 am)
- High-Frequency Express Bus Route
- Only eligible for pre-development grants.



Local Housing Incentives Account (LHIA)

- Apply through Minnesota Housing RFP, intent to apply letters due May 14
- 4.5M Allocated for this funding cycle
- Can fund acquisition, demolition, site preparation, and general construction
- Awarded on a dollar-for-dollar basis with a local match (can be County)
- Priority for:
 - Units affordable at 30% Area Median Income or below
 - Units with two or more bedrooms
 - Proposals that serve people experiencing long-term homelessness



LCA (re)Enrollment Update



- December 2019 May 2020: Staff worked with current LCA participants, LUAC, Council Members, and Metro Cities to determine 2021-2030 affordable and lifecycle housing goals
- June 2020: All eligible communities were sent letters reminding them of the need for (re)enrollment and requirements for participation.
 - Cities with complete or authorized comprehensive plan updates
 - Cities without complete or authorized comprehensive plan updates
 - Cities not anticipating sewer serviced growth in 2021-2030
- Follow up letters will be sent in late August/early September



Equity and Livable Communities Act

- What inequitable development patterns can LCA address?
 - Affordable housing is less than 20% of all new housing construction, while more than 30% of the region's households are housing cost burdened
 - Less than 20% of the region has sufficient housing options for households earning 30% of the Area Median Income (AMI) or less – this is true for transit station areas as well
 - Less than 10% of new housing built between 2012 and 2016 was in Areas of Concentrated Poverty
 - Black and American Indian residents have longer travel times to work than any other race
- What other inequitable development patterns do you see?



Equity and Livable Communities Act

- Evaluating applications with an equity lens
 - How do we value and promote equity?
 - What types of scoring criteria can help us measure equitable processes and projects?
- Expanding eligible uses of funds
 - What kinds of uses could we fund to support equitable processes and projects?



Equity and Livable Communities Act

- Communicating and engaging with those under-represented and most affected
 - How can we administer LCA in an equitable way?
 - Who isn't applying for LCA funds and why?
 - How can we broaden our outreach?
- Measuring and monitoring projects for equitable outcomes
 - What data should we collect/track?
 - What monitoring should we do?
- Who else should we be hearing from?
